ORDER AMENDING TEMPORARY
RESTRAINING ORDER ISSUED
MARCH 29, 2017

1 **IT IS FURTHER ORDERED** that the State Public Charter School Authority's
2 ("SPCSA") meeting scheduled for March 30, 2017 is not enjoined and may proceed with
3 any and all matters unrelated to the hearing regarding accountability for Nevada
4 Connections Academy (including allowing members of the public to make comment
5 regarding the Nevada Connections Academy matter), but that the SPCSA meeting must
6 recess prior to the commencement of any action on the Nevada Connections hearing.

7 **IT IS FURTHER ORDERED** that Nevada Connections Academy ("NCA") will be
8 required to secure a venue or venues for a hearing at a later date for the resumption of
9 the March 30, 2017 meeting and the commencement of the hearing regarding NCA
10 accountability and that such venue(s) shall have enough space to accommodate all NCA
11 parents and members of the public who wish to attend the hearing for the number of days
12 commensurate with the good faith estimates of NCA and SPCSA Staff.

13 **IT IS FURTHER ORDERED** that Nevada Connections Academy will cover all
14 the costs for the agreed upon venue and will cover up to \$3,000 of the costs associated
15 with the lost rental for the space obtained to accommodate this week's hearing.

16 **IT IS FURTHER ORDERED** that NCA's request for a continuance shall
17 constitute a waiver of any right to have a hearing within 90 days as required by NRS
18 388A.330(3).

19 **IT IS SO ORDERED.**
