## Agenda Item 1 – Call to Order, Roll Call, and Pledge of Allegiance

Chair Mackedon called the special meeting to order at 9:01am, with attendance reflected above.

### Agenda Item 2 – Nevada Connections Academy

Executive Director Rebecca Feiden provided background on Nevada Connections Academy (NCA) and its performance. She summarized the settlement agreement in which the school is requesting approval from the Authority that states the details of a three-year charter school contract for NCA's high school (grades nine through twelve) and dismissal of the pending litigation, *NCA v. Nevada State Public Charter School Authority* (Case No. 20 OC 00036 1B; First Judicial District Court, Carson City). Executive Director Feiden said she is recommending the Authority resolve the pending litigation initiated by NCA against the SPCSA in regard to the Authority's denial of NCA's renewal application as it related to NCA's middle and high schools, on the terms and conditions outlined in the memorandum. See supporting materials for referenced documents. She emphasized that staff does not believe that the current performance of the high school is adequate.

Chris McBride, Superintendent, Nevada Connections Academy, spoke on behalf of the school and expressed their commitment and understanding to the expectations moving forward, including reaching a 3-star status, at the bare minimum.

Scott Harrington, President, Board of Directors, Nevada Connections Academy, reiterated that their board is committed to moving forward.

There was discussion between the Authority and NCA representatives regarding the school's turnover, attrition, and the expectations for improvements, should the agreement be approved.

There was discussion between the Authority and NCA representatives regarding the turnover of the school's board, whether it is fully constituted, and if they have received independent board training.

Chair Mackedon asked for any public comment.

Executive Director Feiden confirmed there were no submissions via the email address provided on the notice.

No public comment related to this agenda item.

Member Soifer made a motion with (3) parts, (1) to dismiss the present litigation, (2) to agree to the contract for a duration of 3-years as stipulated in the memo dated May 5, 2020, and (3) to agree to the settlement as described in the memo dated May 5, 2020. Member Holmes-Sutton seconded the motion.
