Rooted	2401 East Tonopah, Las Vegas, Nevada 89030 Opening: 9-10 Full scale: 9-12	We have identified our permanent facility (2401 E. Tonopah Ave, North Las Vegas, NV 89030). The deed has been signed, we have completed all necessary due-diligence and neighborhood meetings and are just awaiting our planning and city council meetings in December. We have been informed by all parties involved that there is no pushback, and our councilman is very supportive of our project. Construction for phase 1 is set to begin Jan-Feb. So far, the process has been smooth, but we are aware of potential obstacles that may arise and are in frequent conversation with our facilities partners on any potential risks and how we can mitigate them.	We have committed to both in-person and digital recruiting efforts. We have seen success above industry standards with digital marketing and will be launching a new application-based campaign this week to reach our enrollment goals (180 9th/10th, as stated in our charter). Our inperson recruitment efforts include community events (4 events in the past month at community centers at NLV, Pearson, ELV, and Silver Mesa), speaking at middle schools (Discovery Charter School, Jim Bridger MS, Legacy Traditional next month). We submitted a signed letter of interest and are waiting on the church to return it so we can draft the lease. All parties know we have a January 1 deadline to submit a fully executed lease.	We have a Family Information Night this Thursday, November 30 at Águilas. Our postcards went out at the beginning of November. We plan to open enrollment on December 21 (45 days after the postcards went out), and hold our lottery on February 5th, 45 days after we open enrollment.
