1 BACKGROUND

1.1 HISTORY OF THE STATE PUBLIC CHARTER SCHOOL AUTHORITY (SPCSA)

In 2011, Nevada Legislature created the State Public Charter School Authority, a statewide, executive branch agency tasked with authorizing and overseeing most Nevada's public charter schools. The Legislative purpose of the SPCSA was and is to:

- Authorize charter schools of high-quality throughout this State with the goal of expanding the opportunities for pupils in this State, including, without limitation, pupils who are at risk.
- Provide oversight to the charter schools that it sponsors to ensure that those charter schools maintain high
 educational and operational standards, preserve autonomy and safeguard the interests of pupils and the
 community.
- Serve as a model of the best practices in sponsoring charter schools and foster a climate in this State in which all high-quality charter schools, regardless of sponsor, can flourish.

The SPCSA is currently composed of an Executive Director, appointed by the Governor, 27 full time employees, and is overseen by a nine-member Board. Members of the SPCSA Board are appointed by the Governor, the Senate Majority Leader, the Speaker of Nevada's Assembly, the State Board of Education, and the Charter School Association of Nevada.

Since the creation of the SPCSA in 2011, public charter schools in Nevada have grown significantly. The SPCSA has grown from 15 public charter school campuses serving approximately 11,000 Nevada students in 2011 to 78 public charter school campuses in five counties (Clark, Churchill, Elko, White Pine, and Washoe) serving just under 60,000 Nevada students (approximately 12% of Nevada's public school students) in the 2022-23 school year.

1.2 ANNUAL REPORT BY SPONSOR OF CHARTER SCHOOL (NRS 388A.351)

NRS 388A.351 requires each sponsor of public charter schools authorized and operating in Nevada to annually provide the Nevada Department of Education with information regard the following:

- A description of the strategic vision of the sponsor, and the progress of the sponsor in achieving that vision;
- A list of all public charter schools currently authorized and operating under the sponsorship and oversight of the public charter school sponsor;
- A list of public charter schools that have been approved by the sponsor but have not yet opened;
- A summary of the academic, financial, and organizational performance of each public charter school authorized by each public charter school sponsor;
- A list of public charter schools sponsored by the public charter school sponsor
 - that the public charter school's sponsor has terminated the public charter school's charter contract,
 - o that have voluntarily ceased operations, and
 - that the public charter school's sponsor has not renewed the public charter school's charter school
 contract;
- A list of public charter schools that have requested a change in sponsorship pursuant to NRS 388A.381;
- A description of the services provided by the sponsor pursuant to any service agreements entered into between the sponsor and the governing body of the charter school pursuant to NRS 388A.381, including an itemized accounting of the actual costs of those services; and
- The amount of any money from the Federal Government that was distributed to the charter school, and any concerns regarding the equity of such distributions and any recommendations on how to improve access to and distribution of money from the Federal Government.

2 THE SPCSA'S STRATEGIC MISSION AND VISION [NRS 388A.351(1)(D)]

2.1 THE SPCSA'S STRATEGIC PLAN

The SPCSA's current strategic plan was adopted in December of 2019 and can be found on the SPCSA website (https://charterschools.nv.gov/About/Strategic Plan/). In addition, the strategic plan is summarized below.

2.1.1 Mission

The SPCSA sponsors, supports, and oversees dynamic and responsive public charter schools that prepare all students for academic, social, and economic success.

2.1.2 Vision

Equitable access to diverse, innovative, and high-quality public schools for every Nevada student.

2.1.3 Strategic Goals

Goal 1: Provide Families with Access to High-Quality Schools

The SPCSA aims for all sponsored schools to meet academic, organizational and financial performance standards. Five-year goals:

- a. Improve upon existing strong performance on star ratings by achieving 70% four-star or better, 83% three-star or better, no more than 17% two-star, and less than 4% one star.*
- b. Schools demonstrate strong organizational and financial performance with 95% rated as meeting standards on the SPCSA Organizational and Financial Performance Frameworks.

Goal 2: Ensure that every SPCSA student succeeds - including those from historically underserved student groups
The SPCSA aims for all sponsored schools to demonstrate strong academic growth, high levels of proficiency and ontime graduation across all student groups, including historically underserved student groups. Five-year goals:

- a. Increase the percent of schools that demonstrate, for each student group, a median student growth percentile on the 3rd-8th grade state Math and English Language Arts (ELA) assessments that exceeds the respective group's Nevada median student growth percentile.
- b. For each student group, surpass respective Nevada proficiency rates on the state Math and ELA assessments.
- c. For each student group, surpass respective Nevada 4-year graduation rates.

Goal 3: Increase the diversity of students served by SPCSA schools

The SPCSA aims for sponsored schools to serve a population of students that is representative of the State with regard to race/ethnicity and additional student groups. Five-year goals:

- a. By the 2021-22 school year and thereafter, in *newly created SPCSA-sponsored public charter school seats* (new schools, new campuses, and expansion of existing schools), enroll English Learners, Students Eligible for Free or Reduced-Price Lunch, and Students with Disabilities at rates that are greater than or equal to the respective Nevada enrollment rates.^
- b. While continuing to serve currently enrolled students, in *vacant seats* at existing SPCSA-sponsored schools, enroll English Learners, Students Eligible for Free or Reduced-Price Lunch, and Students with Disabilities at rates that are greater than or equal to the respective Nevada enrollment rates.^

2.2 Progress in Reaching Strategic Mission and Vision

While the last three years have been substantially impacted by the COVID-19 pandemic, the SPCSA has worked to maintain a focus on our strategic plan. Below is a summary of the progress the SPCSA has made since the adoption of the strategic plan in 2019.

2.2.1 Goal 1: Provide Families with Access to High-Quality Schools

When the SPCSA's Strategic plan was adopted during the 2018-19 school year, the vast majority of SPCSA-sponsored charter schools were already meeting expectations for academic performance by earning a 3-star rating or better and a significant percent were exceeding the expectations by earning a rating of 4-stars or better. The SPCSA aimed to continue to build on this high performance by increasing the percent of schools rated as 3-stars or better. Over the last three years, SPCSA-sponsored schools, like schools across the State, have seen significant challenges due to the impacts of COVID-19. During that time, we've also seen an increase in the number of SPCSA-sponsored schools and student served by SPCSA schools. Despite the challenges brought on by the pandemic and the expansion of the SPCSA, the SPCSA has been able to make small gains in the number of schools that earn a 50 index score or greater on the Nevada School Performance Framework (NSPF), which in a typical year would equate to a 3-star or better rating. However, we have seen a decline in the percent of schools that would have earned a rating of 4-stars or better. As the State's education system continues to rebound from the effects of COVID-19, the SPCSA aims to continue to increase the number of schools rated as 3-stars or better, while moving more schools from the 3-star level to the 4- and 5-star level to be on track to meet goals set forth for the 2023-24 school year.

The table below shows the SPSCA's progress in meeting academic performance goals (excluding those schools that are approved to be rated on the Alternative Performance Framework).

In line with the responsibility to ensure strong stewardship of public funds, the State Public Charter School Authority annually evaluates the organizational and financial performance of schools. These evaluations are based on organizational and financial performance frameworks which are grounded in statutory and regulatory requirements and incorporate data from each charter holder's annual financial audit. The SPCSA has set a goal that 95% of schools will be rated as meeting standards on both the organization and financial performance frameworks. The table below shows the progress the SPCSA has made in achieving goals related to organizational and financial performance of sponsored schools.



2.2.2 Goal 2: Ensure that every SPCSA student succeeds - including those from historically underserved student groups Statewide data show that some student groups have historically underperformed relative to their peers on key academic indicators. Those student groups include students qualifying for Free or Reduced-Price Lunch, English Language Learners, and students who receive Special Education services, along with student identifying as Native American, Black or African


American, and Hispanic or Latino. While these opportunity gaps exist within SPCSA-sponsored schools, students attending SPCSA-sponsored schools have mostly outperformed their peers on statewide assessments over the last few years. The graphs below show the percentage point differences in proficiency and graduation rate between the SPCSA and corresponding state student groups from the 2021-22 school year.






2.2.3 Goal 3: Increase the diversity of students served by SPCSA schools

As shown in the graph below, over the last four years, the SPCSA has increased enrollment in three, historically underserved student groups: students eligible for Free or Reduced Lunch, English Learners, and Students with Disabilities. However, as shown in the subsequent graph, there is still significant work to be done to ensure that SPCSA-sponsored schools are serving a population that is representative of the state.

3.3 Schools That Have Transferred Sponsorship [NRS 388A.351(1)(B)(3)]

No charter school has transferred sponsorship to the SPCSA since the last submission of this report.

3.4 Schools Whose Charter Contract Has Been Terminated [NRS 388A.351(1)(B)(4)]

The SPCSA has terminated a charter contract since the last submission of this report.

3.5 Schools Whose Charter Contract Has Not Been Renewed [NRS 388A.351(1)(b)(5)]

Eight schools have charter contracts that expire at the end of the 2022-23 school year. On December 16, 2022, the SPCSA approved all eight charter school renewal applications for terms between three and nine years. No charter contracts under the SPCSA have not been renewed since the last submission of this report.

3.6 Schools That Have Voluntarily Ceased Operation [NRS 388A.351(1)(b)(6)]

No SPCSA-sponsored charter schools have voluntarily classed operation since the last submission of this report.

4 ACADEMIC, FINANCIAL, AND ORGANIZATIONAL PERFORMANCE OF SPCSA-SPONSORED PUBLIC CHARTER SCHOOL

4.1 BACKGROUND

In accordance with NRS 388A.270, the SPCSA's Performance Framework provides for the evaluation of schools based on their ability to operate as sound, independent entities that successfully serve all students. The SPCSA's performance framework includes three components:

Academic – The SPCSA Academic framework is based on the Nevada School Performance Framework (NSPF), which is released annually by the Nevada Department of Education. The SPCSA framework also reviews diversity and geographical comparisons when rating schools.

Financial – The near-term fiscal health of schools is assessed through four measures: 1) Current Ratio; 2) Unrestricted Days Cash on Hand; 3) Enrollment Forecast Accuracy; and 4) Debt Default. The longer term, fiscal sustainability of schools is assessed through four different measures: 1) Total Margin; 2) Debt to Asset Ratio; 3) Cash Flow; and 4) Debt Service Coverage Ratio. Schools are evaluated against these measures annually.

Organizational – These indicators define the operational and compliance standards to which all charter schools are held accountable in terms of meeting minimum legal and ethical requirements. They include a review of five key categories: 1) Education Program, 2) Financial Management and Oversight, 3) Governance and Reporting, 4) Students and Employees, and 5) School Environment.

4.2 Current Performance of SPCSA-Sponsored Schools [NRS 388A.351(1)(a)]

Overall, the majority of SPCSA-sponsored schools are meeting or exceeding expectations on the SPCAS's Performance Framework. A summary of results for the 2021-22 School year can be found below:

5 SERVICE CONTRACTS BETWEEN THE SPCSA AND SPCSA-SPONSORED CHARTER SCHOOLS [NRS 388A.351(1)(D)]

NRS 388A.381 contemplates sponsored public charter schools entering into contracts with the public charter school's sponsor for support and services not covered by the sponsorship fee paid to the sponsor by the public charter school.

Currently, no SPCSA-sponsored public charter school has entered into such a contract with the SPCSA.

6 FEDERAL GRANTS [NRS 388A.351(1)(E)]

NRS 388A.351(1)(e) asks each sponsor of public charter schools in Nevada to provide the Department of Education with (1) the amount of federal grants received by each sponsored-public charter school, and (2) and "any concerns regarding the equity of such distributions and any recommendations on how to improve access to and distribution of money from the Federal Government."

Current, there are no concerns regarding the equity of the distribution of federal grants. Data regarding the amount of federal grants received by each SPCSA-sponsored public charter school can be found in Appendix B.
