### **Summary of Request and Recommendation**

Discovery Charter School (Discovery) has submitted an amendment application requesting that the State Public Charter School Authority (SPCSA) grant a Good Cause Exemption and approve the school to reduce its enrollment cap at the Sandhill campus for 2022-2023 school year.

SPCSA staff has reviewed the application and recommends that the Authority grant the Good Cause Exemption and approve the amendment request. A proposed motion can be found on page of 3 this memo.

### **Background and Overview of the Amendment**

Discovery currently operates two campuses in Clark County: the Hillpointe campus, which is located at 8941 Hillpointe Rd, Las Vegas, NV 89134, and the Sandhill campus, which is currently located at 3975 S Sandhill Rd, Las Vegas, NV 89121. As of the 2022 Validation day, the Sandhill campus had 89 students enrolled. Discovery was renewed by the Authority at the December 16, 2022, board meeting for a four-year charter term beginning July 1, 2023. The leadership team consists of Principal Tricia Wilbourne and Assistant Principal Denise Koch. The mission of Discovery is, "To promote a safe, nurturing environment which fosters student success through community involvement, progressive educational practices, and innovative use of technology." Along with being approved for renewal at the December 16, 2022 meeting,

Discovery also submitted a request to amend its charter, and was approved to relocate the Sandhill campus to 4801 South Sandhill Road, Las Vegas, NV 89121 beginning in the 2023-24 school year.

Discovery is requesting an amendment to approve an enrollment reduction at the Sandhill campus for the 2022-23 school year only. If approved, the Sandhill campus enrollment cap for the remainder of the charter term would be:

According to the amendment application, Discovery is seeking this amendment to comply with its current charter enrollment cap of 120. Discovery stated that its enrollment as of February 14, 2023, was 101 students and is 7 students below the 10% threshold of the 210 cap. According to the amendment application Discovery seeks to decrease its enrollment cap to 100 for the remainder of SY 2022-2023 and will keep the cap set at 120 students starting in 2023-24.

As previously mentioned, Discovery was approved to relocate the Sandhill campus at the start of the 2023-24 school year and expects this relocation to assist in increasing enrollment beginning next school year. In addition to the relocation, Discovery noted they are canvassing the surrounding Sandhill neighborhoods with marketing information and engaging in outreach to nearby preschools as well.

Finally, according to the amendment application, Discovery does not anticipate staffing or budgetary impacts as a result of the proposed reduction in enrollment.

### Legal Authority and Requirements Related to Amendment Requests

Existing charter schools that are sponsored by the SPCSA may submit a charter school contract amendment application to the SPCSA – which is reviewed by SPCSA staff and presented for SPCSA Board action – in order to, among other things, increase enrollment, add grade levels above and beyond what the charter school is approved to serve, or add a new campus. When determining whether to approve an amendment request, the sponsor considers the charter school's compliance with applicable local, state and federal laws and regulations and evidence relating to the academics, finance and organization of the charter school. (See NAC 388A.400(8) and NRS 388A.276).

### **Analysis and Staff Recommendation**

When reviewing an amendment application, SPCSA staff reviews the academic, financial and organizational performance of the applicant charter school. Since the onset of the COVID-19 pandemic, SPCSA staff has waived the requirement that schools maintain enrollment levels at or above 90% of their contractual cap due to the many extenuating circumstances impacting students and families. Staff believes schools are now better positioned to adhere to this requirement for the 2022 – 23 school year, necessitating this amendment. Discovery Sandhill is currently rated as a 2-star elementary school program and the Hillpointe elementary and middle school campuses are rated as 4-stars according to the 2018 – 19 NSPF ratings. The Hillpointe

elementary and middle school received 69.9 points and 75.2 points respectively on the points 2021-2022 SPCSA Academic Performance Framework. The Sandhill elementary campus did not meet standard on the 2021-2022 SPCSA Academic Performance Framework and received 33.2 points.

Additionally, the school earned 95 points (out of 100) under the SPCSA Organizational Performance Framework for the 2021 – 22 school year as approved by the Authority on December 16, 2022. As such, SPCSA staff finds the school to be 'Meeting Standards.' Discovery has also been found to 'Meet the Standards' on the most recent 2021 SPCSA Financial Performance Framework.

SPCSA staff is supportive of the request by Discovery. As previously stated in this memo, Discovery was approved to relocate the Sandhill campus and staff along with Discovery is hopeful this new location will allow the Sandhill campus to meet enrollment targets beginning in the 2023-24 school year. Discovery explained they are canvasing neighborhoods and preschools in the nearby community and had already shown an enrollment increase as of the January 2023 SPCSA monthly enrollment check. As such, SPCSA staff recommends the Authority approve Discovery's request to reduce its enrollment cap for the 2022-23 school year.

Proposed Motion: Grant the Good Cause Exemption request and approve the Discovery Charter School's request to reduce the Sandhill campus's 2022-2023 approved enrollment cap from 120 students to 100 students.

If approved, the enrollment cap for Discovery's campuses will be as follows for the remainder of the charter term:
