Strong Academic Performance

Without strong academic performance, students will not be prepared for academic, social, and economic success

Effectively Run and Legally Compliant

If a school is not effectively run and legally compliant it runs the risk of not being able to operate (e.g. health and safety, building permitting, etc.) or misusing taxpayer dollars

Financially Sustainable


If a school is not financially sustainable it may not have sufficient funds to continue to operate

Performance Frameworks

- Sponsors are required to *adopt a Performance Framework* which includes measures and metrics related to academics, finances and organization; the Performance Framework must be incorporated into the charter school contract (NRS 388A.273)
- Sponsors must *annually evaluate* schools against the Performance Framework and report the results to NDE (NRS 388A.351)
- Results against the Performance Framework must be *considered in high-stakes decisions*
 - Schools are required to meet the requirements of the Performance Framework in order to be approved for *expansion* (NRS 388A.279(3))
 - *Renewal* decisions must take into account the school's performance in accordance with the Performance Framework (NRS 388A.285)
 - School contracts may be *terminated* if they fail to meet the requirements of the performance framework (NRS 388A.330 and NAC 388A.350)



Nevada School Performance Framework

- Issued for all public schools statewide
- "Star Ratings" (1-5 stars)
- Measures include
 - Elementary/Middle: Proficiency, Growth, EL Proficiency, Closing Opportunity Gaps, Chronic Absenteeism
 - High: Proficiency, Graduation Rate, EL Proficiency, Participation and Completion in Post-Secondary Prep Programs, Advanced/CCR Diplomas rate, Chronic Absenteeism, Credit Sufficiency
- NRS 385A.720

SPCSA Academic Performance Framework

- Issued for SPCSA-sponsored schools only
- Four rating levels (Exceeds, Meets, Does Not Meet, Below)
- Measures Include:
 - NSPF Index Score, Geographical Comparison, Enrollment Diversity
- NRS 388A.273

Academic Performance Statutes

Mandatory Termination

"...the sponsor of a charter school shall terminate the charter contract of the charter school or restart the charter school under a new charter contract if the charter school receives, in any period of 5 consecutive school years, three annual ratings established as the lowest rating possible indicating underperformance of a public school, as determined by the Department pursuant to the statewide system of accountability for public schools." (NRS 388A.300)

Permissive Termination

The sponsor of a charter school may reconstitute the governing body of a charter school or terminate a charter contract before the expiration of the charter if the sponsor determines that...

- The charter school has a graduation rate below 60%
- The elementary school is rated in the lowest 5 percent of elementary schools or middle schools in the State
- The charter school was rated as 1- or 2-stars for 3 consecutive years
- The charter school has not complied consistently with the performance indicators, measures and metrics set forth in the performance framework



Notice of Concern	 Evidence of weak financial, academic or organizational performance through ongoing oversight or at the time of annual review Repeated or material failure to submit Reporting Requirement Manual items in a timely and/or complete manner 	 Written notification to charter school governing body detailing area(s) of concern, expected actions on the part of the school, and time to remedy as applicable
Notice of Breach	 Continued evidence and/or significant evidence of material weak financial, academic or organizational performance through ongoing oversight or at the time of annual review Failure to make substantial progress towards remedying previously-identified concern Failure to comply with applicable laws, regulations and/or the terms of the charter contract 	 Written notification to charter school governing body detailing area(s) of deficiency May require corrective action plan, a site visit and/or site evaluation
Notice of Intent to Revoke	 Serious violations of laws, regulations and/or the charter contract through ongoing oversight or at the time of annual review; or Patterns of failure to comply with performance standards 	 Written notification to charter school governing body regarding termination and school closure

Meeting Some Expectations: Star Rating is 3-stars or above OR SPCSA Performance rated as Meets or Exceeds Standards	May Issue Notice of Concern	May Lift Notice, Escalate Notice, or No Action (existing Notice remains in place)
Not Meeting Expectations: Star Rating is 1- or 2-stars AND SPCSA Performance is rated as Does Not Meet or Below Standards	Issue Notice of Concern	Escalate Notice of Concern to Notice of Breach; <i>May</i> escalate Notice of Breach to Notice of Intent to Revoke*
