Agenda Item 1 – Call to Order, Roll Call and Moment of Silence

Danny Peltier, Management Analyst III, provided the Authority with recommendations related to charter school contract amendment applications, and the Authority may approve or deny the following charter school contract amendment applications based on NRS 388A.276 and NRS 388A.279

- a. Coral Academy of Science Las Vegas Cadence Campus
 - i. Reduction of enrollment cap
- b. Coral Academy of Science Las Vegas Nellis Campus
 - i. Expand enrollment in existing grades, Nellis
 - ii. Construct facility for expansion, Nellis

Motion: Member Thigpen made the motion to grant the Good Cause Exemption request and approve Coral Academy of Science Las Vegas requests to: reduce the enrollment cap at the Cadence campus for the 2023-24, 2024-25, and 2025-26 school years; expand enrollment at the Nellis campus in existing grades beginning in the 2026 – 27 school year and continuing through the 2028 – 29 school year; and expand the facility at the Nellis AFB with the following condition that the school complete the SPSCA pre-opening process for new schools and campuses for occupation of the additional facility space at the Nellis campus. The motion was seconded by Member Kinne and passed unanimously.

Agenda Item 8 - Organizational Performance Review and Recommendations for the 2022-23 School Year

Mike Dang, SPCSA Finance and Organizational Manager, provided the Authority with school-level results and recommendations regarding organizational performance for the 2022-23 school year, including issuing Notices of Concern.

a. 2022-23 SPCSA Organizational Performance Framework Ratings

Motion: Member Olsen made the motion to accept the 2022-23 SPCSA Organizational Performance Framework and delegate to staff the authority to provide final results to governing boards of each charter in the coming weeks. The motion was seconded by member Thigpen and passed unanimously.

b. Issue Notices of Concern - Nevada Prep Charter School

Motion: Member Olsen made the motion to approve SPCSA staff recommendation to issue notification of Notice of Concern to Nevada Prep Charter School. The motion was seconded by member Thigpen and passed unanimously.
