Learning Bridge Charter School Request to Occupy a Temporary Facility

Request to Occupy a Temporary Facility was approved by the Learning Bridge Board of Directors on August 21st, 2018

Learning Bridge Charter School is requesting to occupy a temporary facility for four classrooms. Sacred Heart Catholic Religious Education Center used to be a Catholic Elementary school. This building will accommodate 2nd, 3rd, 4th & 5th grade classes for a total of 80 students.

Learning Bridge is committed to providing a full a detailed response to this question by a mutually-agreed upon deadline with Authority staff. The school and Board understand that sufficient information within the temporary facility amendment request is needed so as to safeguard students and ensure compliance with state and federal law as well as Authority regulations.

Documentation demonstrating that the proposed facility meets all applicable building codes, codes for the prevention of fire, and codes pertaining to safety, health and sanitation OR a detailed construction project plan and timeline, including a Gannt chart, identifying all facility development activities necessary to obtain all such code approvals prior to the first day of school <u>AND</u> documentation of the inspection and approval processes and timelines for the state, municipal, or county agencies which will conduct all code inspections, including a discussion of whether such agencies issue temporary or conditional approvals and a copy of the standard form documentation that the sponsor can consult in such circumstances to confirm compliance with NAC 386.3265.

10. Documentation demonstrating the governing Body has communicated with the Division of Industrial Relations of the Department of Business and Industry regarding compliance with the federal Occupational Safety and Health Act (OSHA) in compliance with NAC 386.3265

The school and Board understand that sufficient information within the temporary facility amendment request is needed so as to safeguard students and ensure compliance with state and federal law as well as Authority regulations.

ONGOING OPERATIONS

(1) Discuss the types of insurance coverage the school will secure as a result of the occupation of the temporary facility, scope of operation and the attendant risks, including a description of the levels of coverage. Types of insurance should include workers' compensation, liability insurance for staff and students, indemnity, directors and officers, automobile, and any others required by Nevada law or regulation. As the minimum coverage required by Nevada law and regulation is intended as a baseline requirement for schools which operate at a significantly smaller scale, schools requesting an amendment are expected to research the levels of and types of insurance coverage typically required of and obtained by similarly sized schools in other states, including but not limited to Arizona, California, Colorado, the District of Columbia, Massachusetts, and New York, and crosswalk those

levels of coverage with those the school intends to obtain to ensure that the governing body and leadership is fully cognizant of the complexity of risk management at a temporary facility.

E.H. Hursh Inc. Insurance has been notified about providing coverage for both Learning Bridge School and temporary coverage to occupy Sacred Heart RE Center. Currently we are awaiting the written documentation. Russ Mower at the Diocese of Las Vegas has verified that our coverage is valid and suitable liability coverage. He is awaiting the Certificate of Occupancy before submitting written approval.

Timeline

Learning Bridge will begin school on Tuesday, September 4th, 2018 at both Learning Bridge and Sacred Heart sites. The construction has been reported to take an estimated six weeks. (Best case, we would move back into Learning Bridge to resume school on October 1st.) Asbestos abatement began on Monday, August 20th with the expected completion on August 28th. Then the subfloor and carpet construction will take place.

Assurance

The Learning Bridge Charter School Board and the representatives from Sacred Heart understand that the Diocese of Las Vegas will not exercise any control over the educational programs of the charter school, pursuant to NRS 388A.090.

Financial Plan

Currently no rent payment will be required from Learning Bridge to temporarily occupy Sacred Heart RE Center. However a lease agreement with that in writing is still needed.
