The City of Henderson supports the application for Alakai Heritage Academy (AHA). Residents of the City of Henderson place the quality of a public-school education as a top priority. The Henderson Strong Comprehensive Plan seeks to support educational institutions in providing high quality K-12 learning environments to prepare today's youth for future success. The application for AHA appears to address this goal and engages the underserved student populations as identified in the 2019 Academic and Demographic Needs Assessment. Furthermore, all of the schools located in the area AHA is proposing to locate are more than 100% over program capacity, with multiple schools in the area at more than 125% over program capacity. AHA addresses the severe overcrowding by proposing to locate in an area with these issues, which indicates a commitment to delivering a quality public school education. Applicant should review the Henderson's Development Code for school siting requirements. The Code prioritizes locations and designs that allow a maximum number of students to walk or bike to school; safe and efficient multimodal access, parking, and circulation; separation from noise and environmental pollution; integration with neighborhood parks and community services; and sufficient space for outdoor recreation. AHA should give preference to students residing within a 2 mile-radius from the school to promote walking and bicycling.
