Growth Measure of Achievement	Status Measures of Achievement					
Student Growth is a measure of performance on the State assessments over time. Students who perform similarly on the first administration of the test are compared to each other after the second. Each student's relative performance to each other is measured as a percentile. This value is called the Student Growth Percentile or SGP. Separate SGP determinations are made for Reading/ELA and Math.	Status is a measure of student performance based on a sin administration of the State assessment. Cut scores are set to determine the achievement level needed to be proficient on a assessments. Status Measures of Achievement are determined calculating the percent of students in the school who met or exceed standards on the State assessments. Student achievement targets to meet proficiency on the State assessments within three years are determined for each elementary and middle school student. 
