CCSD, Demographics, Zoning and GIS (DZG) response:

The provided zip codes of intended service encompass a massive geographic area with thirty-eight elementary schools, ten middle schools and four high schools. Through the 2015 Capital Improvement Program, the Clark County School District has invested heavily within these zip codes to support the community needs. Seven of these schools have received or are scheduled for a replacement facility; Lincoln Elementary School (2017), Heard Elementary School (2017), Griffith Elementary School (2019), Mackey Elementary School (2020), Wasden Elementary School (2020), J.D. Smith Middle School (2020), and Tate Elementary School (2021). Six elementary schools have received building additions, adding needed capacity and modernization; C. Cox Elementary School (2018), Craig Elementary School (2018), Lowman Elementary School (2018), Squires Elementary School (2018), Woolley Elementary School (2018), and Cortez Elementary School (2020).

Below is information regarding the analysis of <u>Pioneer Technology and Arts Academy</u>, in reference to the applicant aligning with the identified needs of the community.

Demographics: The application <u>does</u> provide evidence of service to the required demographics (students qualifying for free or reduced-price lunch, English learners, and students with IEPs), in the following zip codes; **89030, 89032, 89034, 89081, 89107** and **89115**. However, the application <u>does not</u> provide evidence of service to the required demographics if placed in the following zip codes; **89027, 89034** and **89117**.

Academic Geographies:

The applicant has proposed locations in the City of Las Vegas within the following zip codes (89030, 89032, 89034, 89081, 89107 and 89115), that <u>does</u> meet the criteria of elementary, middle and high school geographies with 1- and 2-Star schools. In addition, the applicant proposes possibly locating in the 89117 zip code, which <u>does not</u> align with serving the intended community. Furthermore, the applicant has proposed possible locations in the City of Mesquite (89027 and 89034) that <u>does not</u> meet the criteria of elementary, middle and high school geographies with 1- and 2-Star schools.

Social Emotional: The applicant <u>does</u> provide information regarding the school's ability to address the social and emotional needs of the stated demographics.

Academic Learning Models: The applicant <u>does</u> provide evidence of a typical learning model.

Financial Plan: The applicant <u>does</u> provide initial financial analysis and information.

Successful History: The applicant <u>does</u> demonstrate the capacity in which it previously successfully supported student populations in grades K-12 in achieving academic performance at or above the State average.
