TEACH Las Vegas received charter approval less than 60 days prior to the due date of this loan application. TEACH Las Vegas assures that the controls will be established and documented prior to the issuance of the loan. TEACH Las Vegas will be implementing the same system of fiscal controls and policies as its CMO partner, TEACH Public Schools. These fiscal policies and procedures were included in the approved charter application and have been evaluated annually by an independent auditor. TEACH Nevada will greatly benefit from having start-up funds that will assist with start-up cost until the School's apportionments are received. In the event, that TEACH Nevada does not obtain the loan, it is highly unlikely that there would be a reduction of current budgeted expenses unless there is a significant decrease in the number of students that are anticipated to enroll. If enrollment numbers are as projected, TEACH Nevada will have to try to obtain additional funding through other organizations. TEACH Nevada has currently applied for the "Great Schools Nevada Grant". These funds will also assist with pre-operational and post-operational cost until State funding is received.

- Mr. Brown presented the revolving loan application. Ms. Lukesh asked about the recourse on the loan. Mr. Brown stated he asked this question to SPCSA staff during the pre-opening checklist meeting. SPCSA staff said that they put a intercept in place on the schools state revenue to ensure payment. A school has never been unable to pay the loan before, however in such a case board members would not be personally responsible for repayment. Additionally, the board will have D&O insurance coverage in advance of any execution of loan documents. Ms. Lukesh moved to approve the TEACH Las Vegas revolving loan application for the maximum (\$200k) amount allowable. Mr. Horn seconded. Approved 6-0.
- Mr. Brown informed the board that he is awaiting quotes on D&O insurance coverage (currently in underwriting) and should have them by next week.
- Mr. Brown, Dr. Pimienta and Dr. Carranza provided updates on the pre-opening process including staffing, student recruitment, scheduled open houses and facilities work. Ms. Lukesh asked how the board could help. Dr. Pimienta stated spreading the word about TEACH in the community. Ms. Lukesh suggested a Top 10 talking points about TEACH document. Dr. Pimienta said this was a great idea and she would prepare something and share with the board. The board shared some idea about marketing the school.
- The next regular meeting of the TEACH LV board is scheduled for March 31st at 5pm. A annual board meeting calendar will be adopted at the next board meeting. The board prefers Tuesday nights at 5pm.

Ms. Igeleke moved that the meeting be adjourned at 5:44pm.


