Site Evaluation Purpose

- To gather quantitative and qualitative data and evidence.
- Monitor academic and organizational performance of SPCSA schools.
- Document progress toward goals outlined in schools' charter.
- To ensure accountability as a state authorized public school.





- Academic Performance
- Organizational effectiveness of the school
- Adherence to the approved charter and charter contract with the SPCSA



Site Evaluations

Are not:

- •Critiques of the school model
- Micromanagement opportunities
- Evaluations of teacher performance



Are:

- •An opportunity to triangulate reports and data with qualitative information
- •An opportunity to build/strengthen relationships with schools
- •An opportunity to provide an outside perspective
- •An opportunity to provide objective suggestions for best practices to fulfill charter contract and meet needs of all students
- •An opportunity to review the alignment between implementation and charter contract

Site Evaluation Experience

The SPCSA aims to provide a high-quality site evaluation experience by:

- Utilizing effective communication
- Providing meaningful feedback
- Building strong relationships with stakeholders

SPCSA strives to meet each of these by weaving in the three expectations through each step of the site evaluation process; pre- site evaluation, during the site evaluation, and post site evaluation.






2021-2022 Data

2021-2022 Data

- All schools with a charter contract in years 1, 3, or 5 were evaluated as scheduled. Follow up site evaluations are conducted for schools with strong recommendations and/or deficiency.
- A total of **42** Site Evaluations were conducted during this school year.
- A total of 691 classrooms were observed.
- An average of **17** classroom observations per school.
- Evaluations took place between September 2021 and May 2022.
- 41 out of 42 SE reports was sent to each school leader within 8 weeks or before.

Strength: Implementing Strategies Aimed at Closing Opportunity Gaps



- Additional staff (e.g., interventionists, data analyst, strategists, parapros, co-teachers, and aides)
- Professional Learning Communities (PLCs)
- Tailored instruction to meet student needs
- Professional Development
- Small group instruction
- Before and after school tutoring
- Saturday school
- Power hour
- Increased communication to families regarding student progress

Strength: Strategies to Meet Students Social-Emotional Learning Needs

- Additional counselors and safe school professionals to provide whole group, small group, and one on one social-emotional supports to students.
 - * SEL lessons on interacting with other students and self
 - ✤ Social skills lessons on turn taking, sharing, and coping skills
 - Self -regulating lessons on self- awareness, mindfulness, identifying emotions, and managing emotions



Strength: Implementing MTSS with Fidelity through the SPCSA

- Expectations posted in different locations of the school
- Strong adult presence in the common areas to reinforce expected behaviors
- Staff modeled expectations
- Staff redirected behaviors
- Staff provided incentives to students who followed expectations
- Access to MTSS training

Strength: Use of Restorative Justice Practices to Address Behaviors

- Circles
- Class meetings
- Calming areas
- Faculty mentors
- Mindfulness practices



Challenges



- Schools are addressing:
 - Opportunity gaps
 - Regressive social-emotional skills
 - o Challenging behaviors
 - o Teacher shortages
 - Post-COVID challenges
 - Learning Loss
 - $_{\circ}$ Chronic Absenteeism
 - Needs of vulnerable student groups
