The provided zip codes of intended service encompass a geographic area with seven high schools. Through the 2015 Capital Improvement Program the Clark County School District (District) is constructing a new 1,800 seat career and technical high school (2023) which will provide opportunities for students from this area, a cafeteria addition at Eldorado High School (2025) and the replacement of Dell Robison Middle School with a 1,000-seat choice high school (2027) in zip code 89110.



As you know, the SPCSA approved the Academic and Demographic Needs Assessment on July 26, 2019 and approved an updated version on January 22, 2021. The current version was approved on January 28, 2022 and a copy of this version can be found here. Our staff and board will be evaluating the degree to which the applicant aligns with the identified needs.
