Nevada Prep Charter School (NV Prep) has submitted an amendment application requesting that the State Public Charter School Authority (SPCSA) approve the school's request to add grades K – 2 beginning in the 2024-2025 school year. SPCSA staff has reviewed the application and recommends that the Authority approve the amendment request. Director Broughton said SPCSA staff recommends the Notice of Concern be removed from Nevada Prep Charter School due to the school achieving a 3-star or higher NSPF rating and a Meets or Exceeds Standard rating on the SPCSA Academic Performance Framework

**Motion:** Member Thigpen made the motion to approve SPCSA staff's recommendation to issue a Notice of Return to Good Standing to the Nevada Prep Charter School – elementary school due to their improved academic performance. Member Olsen seconded the motion. The motion carried unanimously.

Director Broughton said SPCSA staff recommends Notices of Concern be issued to the specified charter schools due to the school receiving a one- or two-star NSPF rating and a Below or Does Not Meet Standard rating in the SPCSA Academic Performance Framework. School presentations under this item will be limited to a maximum of 10 minutes each.

# i. Battle Born Academy – elementary school (1-star and Does Not Meet Standard);

Director Broughton provided the update regarding the academic performance for Battle Born Academy – elementary school. Kathy Rudd, Principal, Battle Born Academy, provided the school's presentation regarding the school's academic performance. There was further discussion between the Authority and Ms. Rudd. There was discussion between Member Salcido Mr. Ott related to the statutory requirements around maintaining performance and issuing notices.
