Summary of Request and Recommendation

Doral Academy of Northern Nevada (DANN) is requesting that the State Public Charter School Authority (SPCSA) grant a Good Cause Exemption request and approve the school to adopt an updated enrollment lottery priority in accordance with an affiliation agreement with the Board of Regents of the Nevada System of Higher Education, on behalf of the University of Nevada Reno's (UNR) Early Head Start Program.

SPCSA staff has reviewed the application and recommends that the Authority grant the Good Cause Exemption and approve the amendment request. A proposed motion can be found on page of 3 this memo.

Background and Analysis

DANN is located at 3725 Butch Cassidy Dr, Reno, NV 89511and serves 956 students in grades K – 8 as of the 2022 Validation Day. According to the amendment application, the UNR Head Start Program provides center-based early childhood education services for income-eligible pregnant women and families with children aged zero to three, including children with disabilities. DANN and UNR's affiliation agreement will allow any child who is currently enrolled in the UNR Head Start Program or has been enrolled in the program at any time in the past, to receive priority enrollment at DANN.

Furthermore, DANN notes the goals of this amendment request are to continue to provide

a high-quality education, promote greater collaboration in enhancing the family experience transitioning between elementary and middle school, and promote greater proficiency and mastery of academic content or students matriculating from the UNR Head Start Program in their enrollment at DANN.

DANN also noted in the amendment application that this request does not represent a change in academic model or target community of DANN but instead adds an additional priority to the already-approved priority list for students prior to be placed in a lottery. DANN intends to effectively leave in place the same enrollment priorities as prior years for the remainder of the charter contract. Finally, DANN explained that the change will be communicated with DANN families beginning in Fall 2023, pending final approval by the SPCSA board.

Legal Authority and Requirements Related to Amendment Requests

Existing charter schools that are sponsored by the SPCSA may submit a charter school contract amendment application to the SPCSA – which is reviewed by SPCSA staff and presented for SPCSA Board action – in order to, among other things, increase enrollment, add grade levels above and beyond what the charter school is approved to serve, or add a new campus. When determining whether to approve an amendment request, the sponsor considers the charter school's compliance with applicable local, state and federal laws and regulations and evidence relating to the academics, finance and organization of the charter school. (See NAC 388A.400(8) and NRS 388A.276).

Analysis and Staff Recommendation

When reviewing an amendment application, SPCSA staff reviews the academic, financial, and organizational performance of the applicant charter school. DANN has consistently performed at, or above, standards on all SPCSA framework metrics. As of the 2018-19 NSPF ratings, DANN's elementary and middle schools were rated as 5-stars. Moreover, DANN's elementary school received 82.6 points on the 2021-22 SPCSA Academic Performance Framework and was rated as Exceeds Standards; the middle school received 88.9 points and was rated as Exceeds Standard.

DANN earned 94 points (out of 100) under the SPCSA Organizational Performance Framework for the 2021 – 22 school year as approved by the Authority on December 16, 2022. As such, SPCSA staff finds the school to be 'Meeting Standards.' DANN has also been found to 'Meet the Standards' on the most recent 2022 SPCSA Financial Performance Framework, which was approved at the July 28, 2023, SPCSA board meeting.

SPCSA staff is supportive of DANN's request to modify its enrollment priority to include students who are, and have been, enrolled in UNR's Head Start Program. As previously noted in the memo, the Head Start Program provides center-based early childhood education services for income-eligible pregnant women and families with children aged zero to three, including children with disabilities, and providing priority enrollment aligns with the SPCSA's Academic and Demographic Needs Assessment. Additionally, DANN also intends to leave in place all other approved enrollment priorities as prior years for the remainder of the charter contract.

SPCSA staff also notes this request does not affect the school's approved enrollment

cap nor will it have the school's academics or operations. SPCSA recommends the Authority approve DANN's amendment request.

Proposed Motion:

Grant Doral Academy of Northern Nevada a Good Cause Exemption and approve the request adopt an updated enrollment lottery priority to include any child who is currently enrolled in the UNR Head Start Program or has been enrolled in the program at any time in the past.
