This transformative funding will be used to increase Rooted School Foundation's capacity to support existing schools and replicate the successful Rooted model with three new campuses across the U.S One of the proposed campuses is the upcoming launch of Rooted School Las Vegas this August. These resources will be used to build a modern career connected learning high school in North Las Vegas that ensures our students are on a radically accelerated track to increase their upward mobility upon graduation.
