Agreement with an Educational Management Organization

**DATE:** July 26, 2024

#### **Summary of Request and Recommendation**

Oasis Academy (Oasis) is requesting that the State Public Charter School Authority (SPCSA) grant a Good Cause Exemption request and approve the school enter into an Education Management Organization agreement with Academica Nevada.

SPCSA staff has reviewed the application and recommends that the Authority grant the Good Cause Exemption and approve the amendment request. A proposed motion can be found on page of 3 this memo.

### **Background and Analysis**

Oasis is located at 920 W Williams Ave, Fallon, NV 89406 and serves 770 students in grades K – 12 as of the 2023 Validation Day. According to the amendment application, Oasis is seeking approval from the SPCSA to enter into a contractual relationship with Academica Nevada as its Education Management Organization (EMO). This proposed relationship is intended to streamline the Oasis organizational structure by providing comprehensive and cost-effective back-office services and support to allow school leaders to focus on the mission and vision school.

Furthermore, according to the amendment application, Oasis anticipates the EMO's comprehensive back-office services and support will streamline the school's organizational structure and increase cost-effectiveness by decreasing vendor costs which will lead to potential future savings. Additionally, Oasis noted in the amendment

application, that its board acknowledges that Academica Nevada is the largest education service organization in Nevada, providing professional services and related support to numerous public charter schools. The board received a presentation from Academica Nevada at Oasis' April 10, 2024 board meeting and took the opportunity to question Academica Nevada leadership. At the Oasis May 29, 2024 meeting, the Board had a subsequent opportunity to ask additional questions about what a transition would look like to Academica Nevada supporting the school.

The Oasis board voted unanimously to engage Academica Nevada and, pending this amendment approval by the SPCSA, expects to enter into a contract with Academica Nevada as its educational service provider. As a component of the transition, the school expects a reduction in existing school financial team member salary / contracted hours as Academica Nevada team members assist with these functions. Oasis also explained that the governing board will be self-governing and independent from Academica Nevada, and no member of the governing board is employed by the EMO or related to any owner or manager of them. Academica Nevada will not manage the day-to-day operations of the school, but rather will provide "back office" support and independent accountability for the board. Academica Nevada will carry out the defined responsibilities found in the proposed EMO contract and will provide expertise in the areas of business, law, facilities, quality assurance, strategic planning, and governmental compliance. An "arm's length" performance-based relationship will exist between the governing board and Academica Nevada, and the Board will annually evaluate them to determine continuation and renewal of services based on their performance. Moreover, Oasis governing board felt that Academica Nevada's fee were reasonable. The school's board explained in the amendment application that other educational management organizations charge as much as 15% of a school's revenue. Academica Nevada charges a flat annual fee per student enrolled, rather than a percentage like most other management organizations.

## Legal Authority and Requirements Related to Amendment Requests

Existing charter schools that are sponsored by the SPCSA may submit a charter school contract amendment application to the SPCSA – which is reviewed by SPCSA staff and presented for SPCSA Board action – in order to, among other things, increase enrollment, add grade levels above and beyond what the charter school is approved to serve, or add a new campus. When determining whether to approve an amendment request, the sponsor considers the charter school's compliance with applicable local, state and federal laws and regulations and evidence relating to the academics, finance and organization of the charter school. (See NAC 388A.400(8) and NRS 388A.276).

## **Analysis and Staff Recommendation**

When reviewing an amendment application, SPCSA staff reviews the academic, financial, and organizational performance of the applicant charter school. Oasis has consistently performed at, or above, standards on all SPCSA framework metrics. As of the 2022-23 NSPF ratings, Oasis's middle, and high schools were rated as 5-stars and the elementary school was rated as 4-stars. The Oasis elementary school received 75.8 points on the 2022-23 SPCSA Academic Performance Framework and was rated as Meets Standard, the middle school received 85.9 points and was rated as Exceeds

Standard, and the high school received 89.6 points and was rated as Exceeds Standard.

Oasis earned 98 points (out of 100) under the SPCSA Organizational Performance Framework for the 2022 – 23 school year as approved by the Authority on March 1, 2024. As such, SPCSA staff finds the school to be 'Meeting Standards.' Oasis has also been found to 'Meet the Standards' on the most recent 2023 SPCSA Financial Performance Framework, which was approved at the June 21, 2024 SPCSA board meeting.

SPCSA staff is supportive of Oasis's request enter into an agreement with Academica Nevada to provide organizational support to the charter school. Academica Nevada has shown it can be successful in providing support to a wide variety of schools in both Northern and Southern Nevada. SPCSA staff reviewed the fee structure and finds the proposed 5% fee to be reasonable and will work with the school's 2024-25 budget.

SPCSA staff also notes the amendment application contained an evaluation tool the board of Oasis was able to review and approve which will be used for the annual EMO evaluation that is required of all schools who have entered into an agreement with an EMO.

Finally, SPCSA staff also notes this request does not affect the school approved enrollment cap nor will it change anything with regard to the academic mission, vision, and model of Oasis. SPCSA recommends the Authority approve Oasis's amendment request.

## **Proposed Motion:**

Grant Oasis Academy a Good Cause Exemption and approve the request of Oasis to enter into an Educational Management Organization agreement with Academica Nevada.
