#### Site Evaluation Legal Requirements



As approved by the Legislature [NRS-388A.150], the Authority is to "provide oversight to the charter schools that it sponsors to ensure that those charter schools maintain high educational and operational standards, preserve autonomy and safeguard the interests of pupils and the community."

Additionally, <u>NRS 388A.223</u> outlines the monitoring responsibilities of the SPCSA, including the legal requirement to conduct site evaluations of each campus of a charter school it sponsors during the first, third and fifth years after entering or renewing a charter contract.

"Such evaluations must include, without limitation, evaluating pupil achievement and school performance at each campus of the charter school and identifying any deficiencies relating to pupil achievement and school performance. The sponsor shall develop a plan with the charter school to correct any such deficiencies" (NRS-388A.223i).



#### Site Evaluation Purpose



- To exercise oversight, gather formal and anecdotal evidence
- Enhance the SPCSA's monitoring of sponsored schools
- Document strengths of schools, progress toward goals and opportunities to improve
- Leverage best practices of well-established, highly recognized authorizers
- Inform high-stakes recommendations such as renewals and amendments



#### Site Evaluation Focus



- Academic Performance and delivery of instruction
- Organizational effectiveness of the school
- Adherence to the approved charter, contract with the Authority and applicable laws and regulations













# Comprehensive (Years 1, 3, 5)

- Year 1
  - Full Site Evaluation
- Year 3
  - Full Site Evaluation;
    Abbreviated for 4 and 5 Star schools
- Year 5
  - Full Site Evaluation

## Targeted Site Evaluation (Years 2, 4, 6)

- Previous Deficiency or Strong Recommendation
- 1- or 2-Star
- Operating under an academic or organizational notice



#### **Site Evaluations**



- Site Evaluations are one half day to one full day
  - School needs/star ratings
  - Compliance concerns
  - Previously issued Notices (Concern, Breach, Intent to Terminate)
  - High-stakes decision on the horizon
- Site Evaluation teams are made up of two to four team members
  - Allows multiple qualitative datasets
  - Enhances the validity of trends
  - Collaboration of focus group commentary and alignment of direct quotes
- Require some pre-work from schools
  - Gathering of documents not available in Epicenter
  - Schedule and attend virtual pre-site meeting
  - Outreach, with support from SPCSA, to prepare focus groups, leadership presentation
- Final reports and findings pull from the analysis of multiple sources
  - Focus group responses, data collection, observation of classroom instruction and operations
  - Grounded in common best practices of leading authorizers

#### 2023-2024 Site Evaluation Data

- All schools with a charter contract in years 1, 3, or 5 were evaluated as scheduled.
  Follow-up site evaluations were conducted for schools with strong recommendations and/or deficiency.
- A total of **34** Site Evaluations were conducted during the 2023-2024 school year.
- A total of 804 classrooms were observed.
- An average of 24 classrooms observations were conducted per school.
- Evaluations took place between September 2023 and April 2024.

#### **Moving Forward**

- Team members are excited to improve our practice of conducting site evaluations this coming school year. We are currently working on the 24-25 site evaluation schedule which the board will receive once it is finalized.
- The site evaluation team yearly reviews feedback from the SE surveys, anecdotal notes, and data collected from school leadership teams, when considering changes to the site evaluation process.
- The team is in process of revising the handbook and reviewing forms. The site evaluation team will present these proposed changes at the August board meeting.
- The site evaluation team informs school leaders and stakeholders of changes and revisions to the site evaluation process and handbook once approved. We offer virtual workshops for new schools, new school leaders, and any schools desiring to review the process.
