- I. Whether Eagle has failed to comply with generally accepted standards of fiscal management;<sup>1</sup>
- II. Whether Eagle would otherwise be financially impaired such that the charter school cannot continue to operate;<sup>2</sup>
- III. Whether Eagle has failed to comply with any provision of NRS 388A, or any other statute or regulation applicable to charter schools.<sup>3</sup>
