<u>Public Comment</u>: Time for public comment will be provided at the beginning of the meeting regarding any agenda items on which action may be taken by the public body and again before the adjournment of the meeting on any matter within the jurisdiction of the State Public Charter School Authority. See NRS 241.020(2)(d)(3)(I). In addition to these two public comment periods, public comment may also be taken during specific agenda items as noted on the agenda or at the discretion of the Authority Chair.

The State Public Charter School Authority (SPCSA) will hold a public hearing in compliance with the procedures for adjudication of contested cases under NRS 233B to make a final determination regarding the Notice of Termination of Eagle Charter School (Eagle) as approved by the SPCSA board on June 21, 2024, in accordance with NRS 388A.330.

The Board will consider the following:

- I. Whether Eagle has failed to comply with generally accepted standards of fiscal management;¹
- II. Whether Eagle would otherwise be financially impaired such that the charter school cannot continue to operate, should the Board vote to allow Eagle to retain its charter;²
- III. Whether Eagle has failed to comply with any provision of NRS 388A, or any other statute or regulation applicable to charter schools.³
