Motion on Agenda Item 10b: Member Whitaker made the motion to deny the Nevada Early College & Career Academy (Necca Academy) Charter School application as submitted during the 2024 Application Cycle based on a finding that the applicant has failed to satisfy the requirements contained in NRS 388A.249(3) in that the applicant has failed to demonstrate competence in accordance with the criteria for approval prescribed by the SPCSA that will likely result in a successful opening and operation of the charter school. Member Farris seconded the motion. The motion carried unanimously.
