We are pleased to submit our letter of intent to transfer the sponsorship of Rainbow Dreams Early Learning Academy (RDELA) from the Clark County School District (CCSD) to the Nevada State Public Charter School Authority (SPCSA), effective the 2025-2026 academic year. We are excited about this potential transition and believe that our unique, community-centered early learning program aligns well with SPCSA's goals to foster innovative educational approaches and equitable opportunities for students across Nevada. Our program is akin to a "university" for early childhood education, combining rigorous, research-based instructional practices with hands-on, experiential learning. This distinct approach allows us to specialize in preparing young children for lifelong learning while meeting the diverse developmental milestones critical for this age group.

2. Enhanced Early Literacy Focus: RDELA has pioneered strategies to engage families in literacy, helping parents support their children's learning at home and ensuring a strong start in reading skills for all students.

3. Equitable Access to Resources: With over 75% of our students coming from families below 300% of the federal poverty line, we have championed educational equity by removing barriers for our scholars through providing free breakfasts, lunches, and snacks for students, supplies for classroom and family use, access to state-of-the-art technology, peer reviewed curriculum, and highly qualified educators. Through SPCSA sponsorship, RDELA would have the capacity to expand these offerings, ensuring that even more families have access to the resources they need to support their children's education.

As we seek to become part of the SPCSA family, we believe our strengths and innovative practices will significantly enhance the diversity and efficacy of Nevada's public charter school offerings. RDELA's partnership with SPCSA would enable us to further refine our programming



and broaden our impact, creating a sustainable model for early childhood education that aligns with the state's broader educational goals.
