Creates a requirement for school districts that operate programs of education for incarcerated students are required to provide support and assistance to certain students and families in completing the FAFSA and report to the state treasurer certain information related to the support and assistance.
AB156	Assemblymember Erica Mosca	Revises provisions governing the salary of members of the board of trustees of certain school districts.	Increases the pay of CCSD board of trustees member to be equal to the base salary of the Clark County commissioners. It is for members who are elected or appointed to a term of office that begins on or after January 1, 2027.
AB165	Assembly Committee on Natural Resources	Revises provisions relating to outdoor education.	--Establishes the Outdoor Education Council within the Division of Outdoor Recreation. Membership includes an Administrator appointment, a member of NDE appointed by the Superintendent, a member who represents the Department of Wildlife appointed by the Director of the Department of Wildlife, a superintendent appointed by NASS, two licensed teachers appointed by the Governor, two members who are providers of nature-based education and appointed by the Governor, and one nonvoting student member. --Sets out the duties and requirements of the Council, which will be supported by the Division of Outdoor Recreation, including the adoption of necessary regulations.
AB184	Assemblymember Natha Anderson	Revises provisions relating to interscholastic activities.	--Prohibits the NIAA from taking adverse action against a school or person who advocates for or against a policy. --Prohibits the NIAA and any school district or school from considering the zone of attendance in which the student resides in determining if the student is eligible to participate in an interscholastic activity or event. --Prohibits athletic recruitment, requires the NIAA to investigate on a complaint regarding allegations of recruitment, and sets forth penalties for recruitment violations. --Allows for a student who transfers schools to be immediately eligible for athletics if the school uses a lottery system to determine which students may enroll or the student transfers before 10th grade. Eligible students must apply for a waiver from NIAA.
