I, Melissa Mackedon, being the duly appointed Executive Director of the State Public Charter School Authority, do hereby certify, to the best of my knowledge or belief:

1. The proposed regulatory changes regarding the application to form a charter school is not likely to (a) impose a direct or significant economic burden upon a small business, or (b) directly restrict the formation, operation or expansion of a small business.

Proposed Regulatory Amendment (NAC 388A.260)

Statement of Intent:

This regulation identifies the deadline for submitting the new charter application. It is the intent of this regulatory change to change that deadline. This was previously revised in [R043-21](#).

Statutory Authority:

[NRS 388A.168](#)

Proposed Regulatory Amendment:

[388A.260](#) 1. Except as otherwise provided in this section and NAC 388A.270, an application to form a charter school must be submitted to the State Public Charter School Authority by an application between ~~[April 15 and April 30]~~ *January 15 and January 31* of each year. The State Public Charter School Authority may, upon request and for a good cause shown, accept an application to form a charter school at any time.

This provision will go into effect January 1, 2027.
