#### **School Highlight**

According to the National Center on Safe and Supportive Learning Environments [1], positive school culture and climate are critically related to school success. Research shows that they can improve staff attendance, achievement, and retention. During its site evaluation, Pinecrest Academy of Nevada Springs demonstrated a healthy school culture and climate, which serve as a strength and a foundation for school success. A theme that resonated with all focus groups was the positive school culture and climate, which fostered a sense of community within the school. For example, in the staff focus group, most participants noted the school culture and climate as a strength and served as pillars for success. The leadership reported that all staff will return for the next school year, attributing this to the school's positive collaborative work environment. Many participants in the family focus group shared positive school experiences, describing the campus as a family-like atmosphere. Students in their focus group shared stories that aligned with the healthy nature of their school environment. On the day of the site evaluation, staff members were observed numerous times throughout the day displaying a respectful approach when interacting with colleagues, students, and families. For example, staff greeted families with gestures of kindness and by name. The emphasis on creating a positive school culture and climate can be paramount for the school and all stakeholders as they plan for future school expansion, including the addition of new grades.

Additionally, NV Prep received correspondence from PERS on May 27, 2025, stating that "since March 2025 contribution reporting period, and through today's date, Nevada Prep has submitted deficient payment beneath the threshold amounts required by the repayment plan. PERS therefore considers Nevada Prep in breach of the payment plan. . . . PERS will continue to accept Nevada Prep's payments in accordance with the now repudiated payment plan and NRS 286.460, but PERS hereby reserves any and all applicable rights to collect the arrearages and interest penalties in any lawful manner at any time. . ." SPCSA staff will work with NV Prep and PERS to determine the implications.

# Legislative Update

With just a few days remaining in the legislative session, we want to highlight a few key pieces of legislation that will affect charter schools:

- The SPCSA's bill, <u>Assembly Bill 39</u>, has passed the Senate Floor with a floor amendment that will need to be concurred with on the Assembly side of the House.
- <u>Assembly Bill 398</u> passed out of the Assembly. Section 8 of the bill provides \$19,314,297 each year of the biennium for charter school teacher and education support professional salary increases.
- <u>Senate Bill 418</u> is on the Governor's desk for signature. This bill requires NDE to deduct from the charter schools' PCFP payments the amount the school is delinquent on PERS payments when the school is 90 days delinquent.
- <u>Senate Bill 470</u>, the SPCSA revolving loan, was heard in the Assembly on May 27, 2025.
- <u>Senate Bill 468</u>, charter school transportation bill, passed out of Senate Finance on May 27, 2025.
- <u>Senate Bill 500</u> is the education funding bill, which addresses the following for charter schools:
  - Local Funding for Pupils with Disabilities \$24,608,056
  - Base funding for FY26 \$9,416 and FY27 \$9,486
  - Weighted funding for English Learns 0.45, totaling \$27,050,440
  - Weighted funding for at-risk pupils 0.35, totaling \$6,614,302
  - Weighted funding for gifted and talented pupils 0.12, totaling \$1,6,84,719

# **New Charter School Applications Received**

SPCSA staff is pleased to announce that seven new charter applications are currently being reviewed. During the next few months, these applications will undergo a rigorous evaluation of the written application by internal SPCSA staff and external reviewers who engage in this work throughout the country. We will then have capacity interviews, in which we evaluate the capacity of the proposed team. Of the seven applications being reviewed, one is located in Washoe County, one in Carson City, one in Nye County, and the remaining four are within Clark County. Redacted versions of the application are posted on our website for public input. SPCSA staff looks forward to bringing forward recommendations regarding this application cycle in August.

## New Student Representative on the SPCSA Board for the 2025-2026 School Year

The SPCSA received five applicants to serve as the student representative on the SPCSA board. Each member of the leadership team, including the board chair and vice chair, reviewed the applications and ranked their first choice, which received 2 points, and their second choice, which received 1 point. All the applicants were exceptionally impressive, leading to a very close decision. Odalis Ayala from Equipo Academy will serve as our student representative in the coming school year.

## **Current Events in Public Education**

On May 22, 2025, the U.S. Supreme Court issued a 4–4 decision in the case concerning the establishment of the St. Isidore of Seville Catholic Virtual School in Oklahoma. This tie vote leaves the lower court's ruling in place, effectively halting the launch of what would have been the nation's first publicly funded religious charter school. While the decision does not set a national precedent, it reinforces the principle that charter schools remain secular public institutions.

This outcome underscores the importance of maintaining the separation of church and state within our public education system. It ensures that charter schools continue to operate as inclusive, nonsectarian institutions accessible to all students.
