Academic Performance Ratings Overview

a. 2024-25 Nevada School Performance Framework (NSPF) results

- The Nevada School Performance Framework (NSPF) rating system aligns with federal law requiring states to use a school rating system. Each September, the Nevada Department of Education (NDE) publishes NSPF star ratings for all public schools.

b. 2024-25 SPCSA Academic Performance Framework results

- An Academic Performance Framework is required by Nevada state law in all charter school contracts. Each fall, SPCSA staff calculate SPCSA Academic Performance Framework ratings based on NSPF and charter school-specific measures, which provide additional information relevant to authorizing decisions.
- **Recommended action: Adopt the 2024-25 SPCSA Academic Performance Framework results.**

2024-25 Nevada School Performance Framework (NSPF) results

Nevada School Performance Framework (NSPF) Refresher



- The federal Every Student Succeeds Act (ESSA) requires each state to use an accountability system to annually rate all public schools within that state. ESSA also requires states to use their accountability system to identify low performing schools and schools with low performing student groups.
- The NSPF meets those requirements by issuing an annual index score and corresponding star rating to schools based on performance in various measures. The NDE also uses the NSPF to identify schools with low performance and/or low performing student groups.

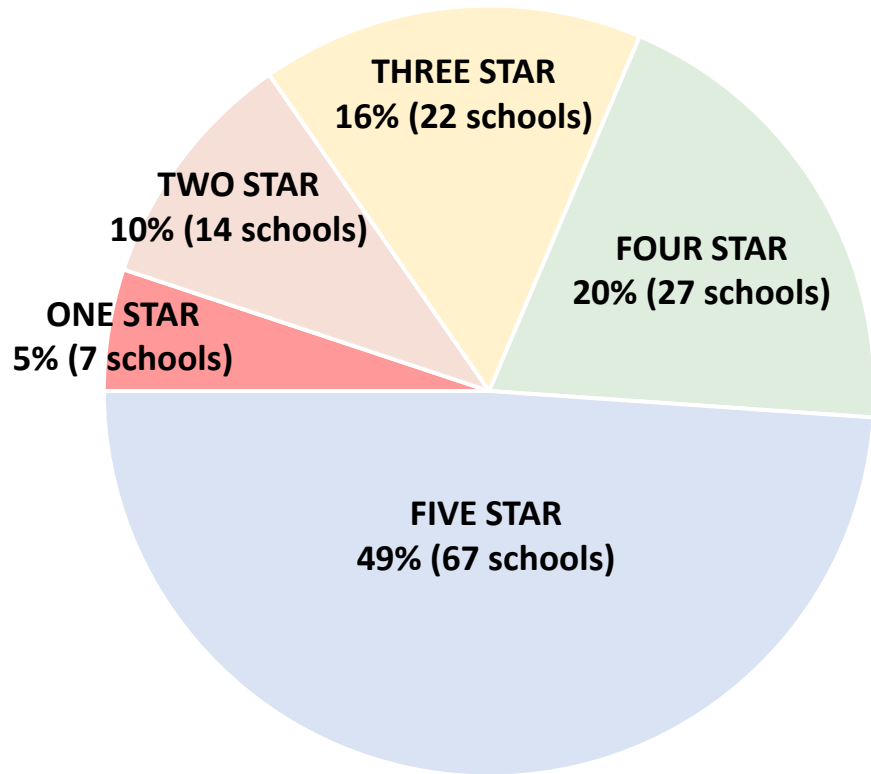

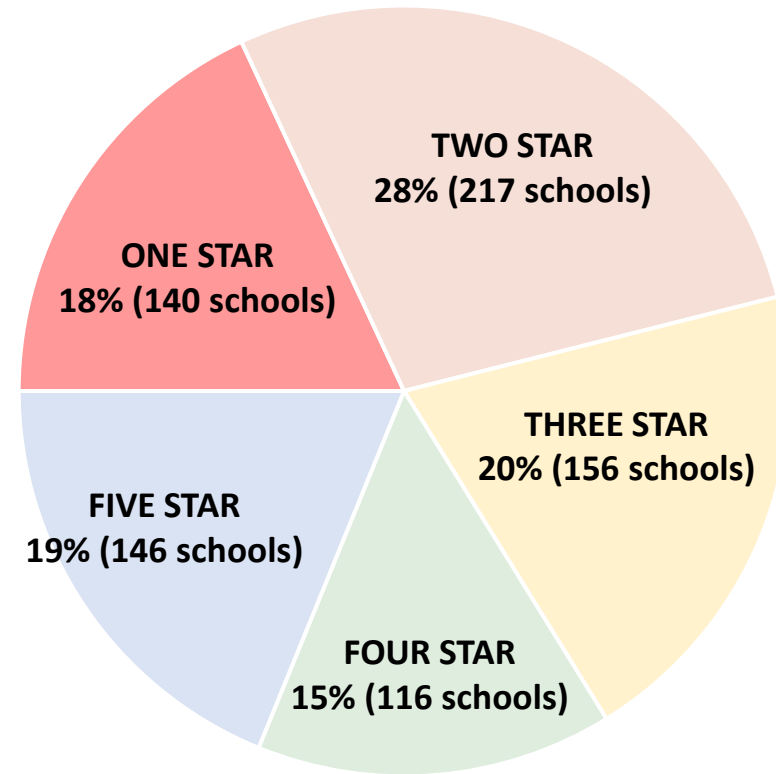

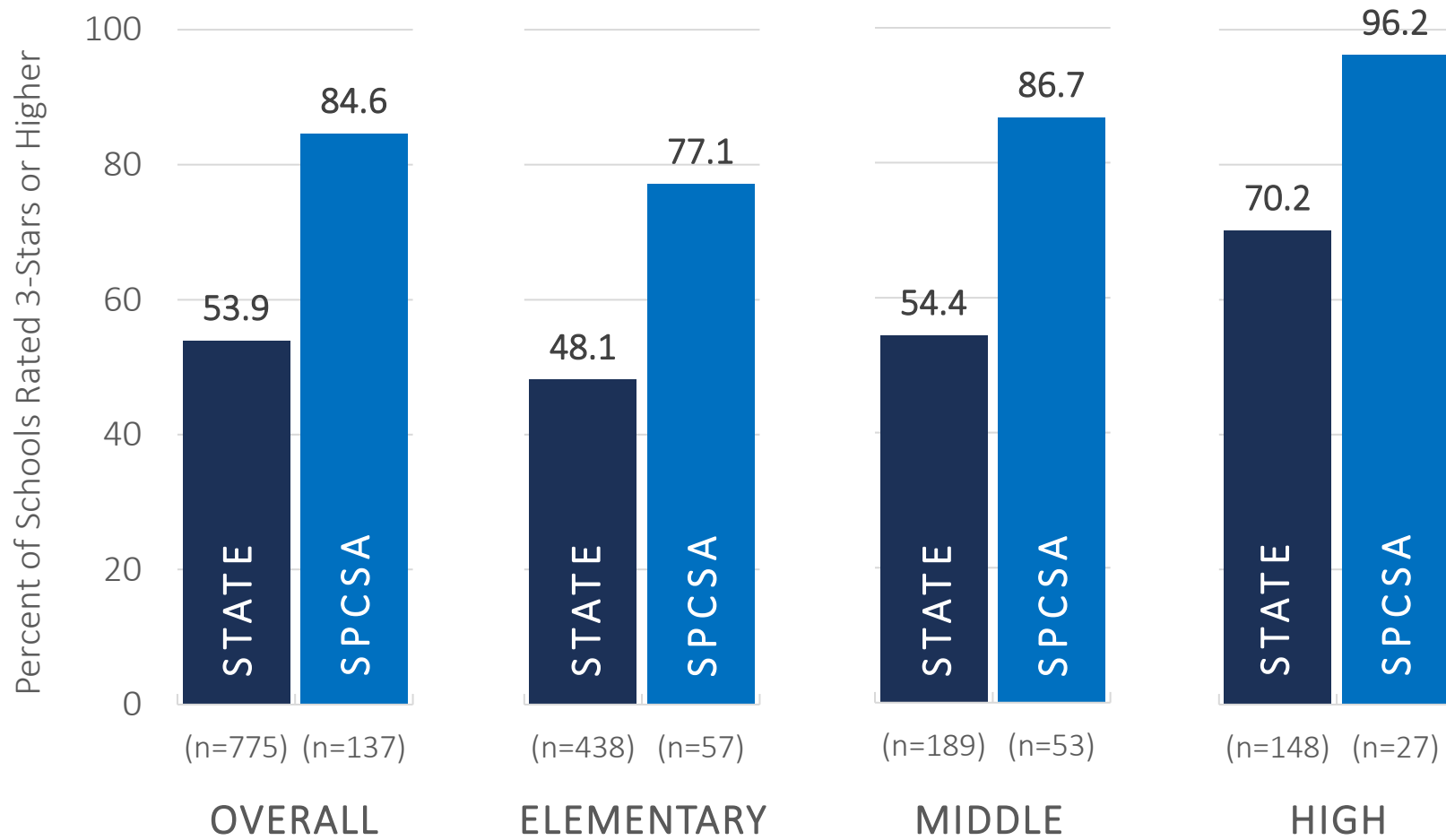

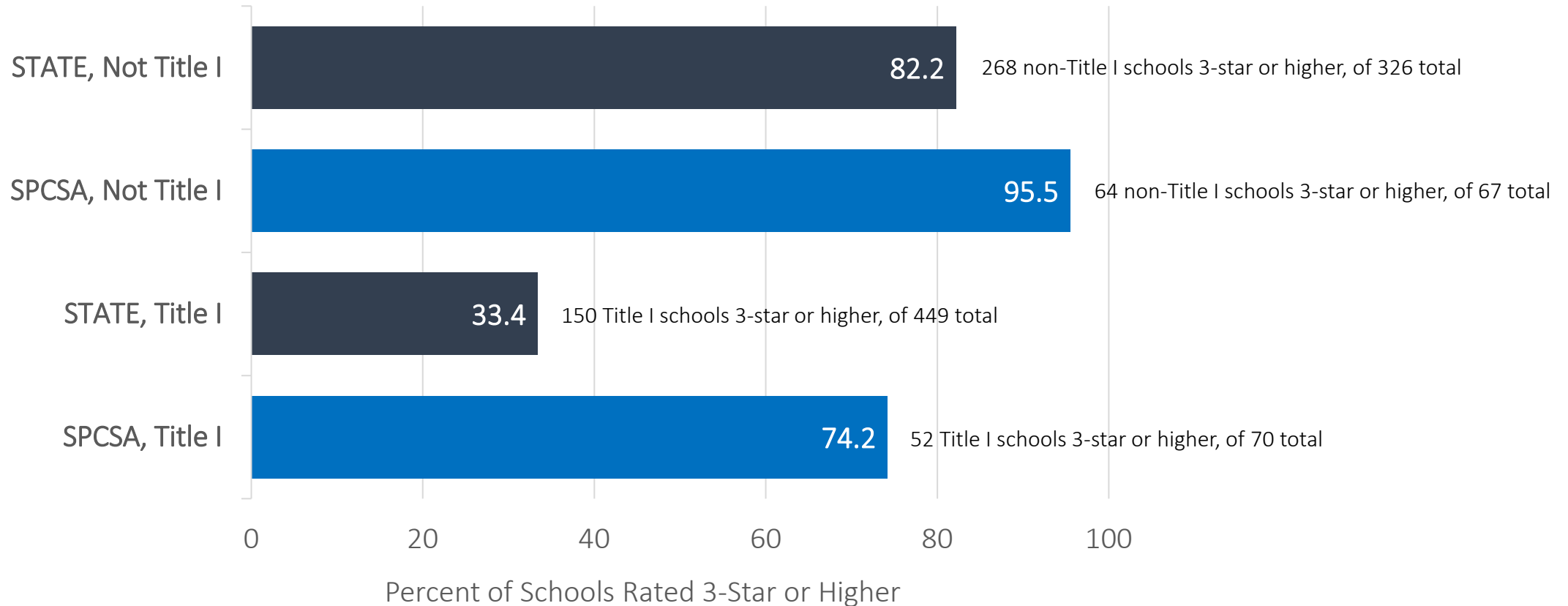

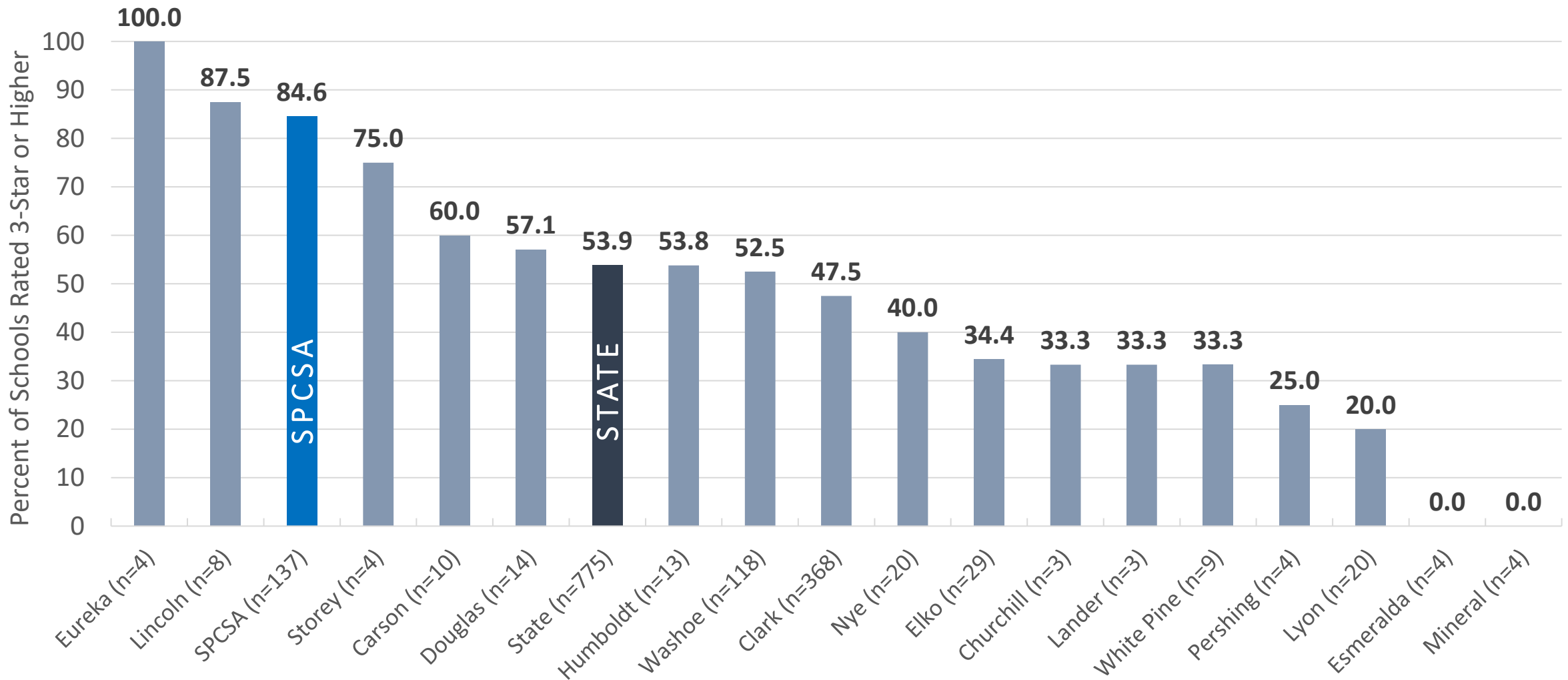
2024-25 SPCSA vs. State: Percent of Schools with 3-Star or Higher NSPF Rating



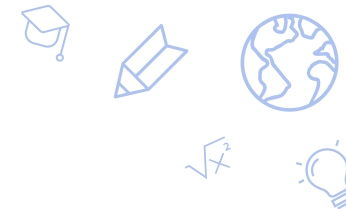
2024-25 Title I School NSPF Ratings

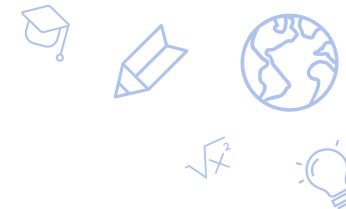

2024-25 NSPF: Identification of Low-Performing Schools

The federal Every Student Succeeds Act (ESSA) requires states to use their rating system to identify low performing schools and schools with low performing student groups.

Comprehensive Support and Improvement (CSI)

Lowest performing schools in the state (statewide lowest 5th percentile NSPF score, <67% graduation rate). Schools spend three years as a CSI school and must meet certain criteria to exit.

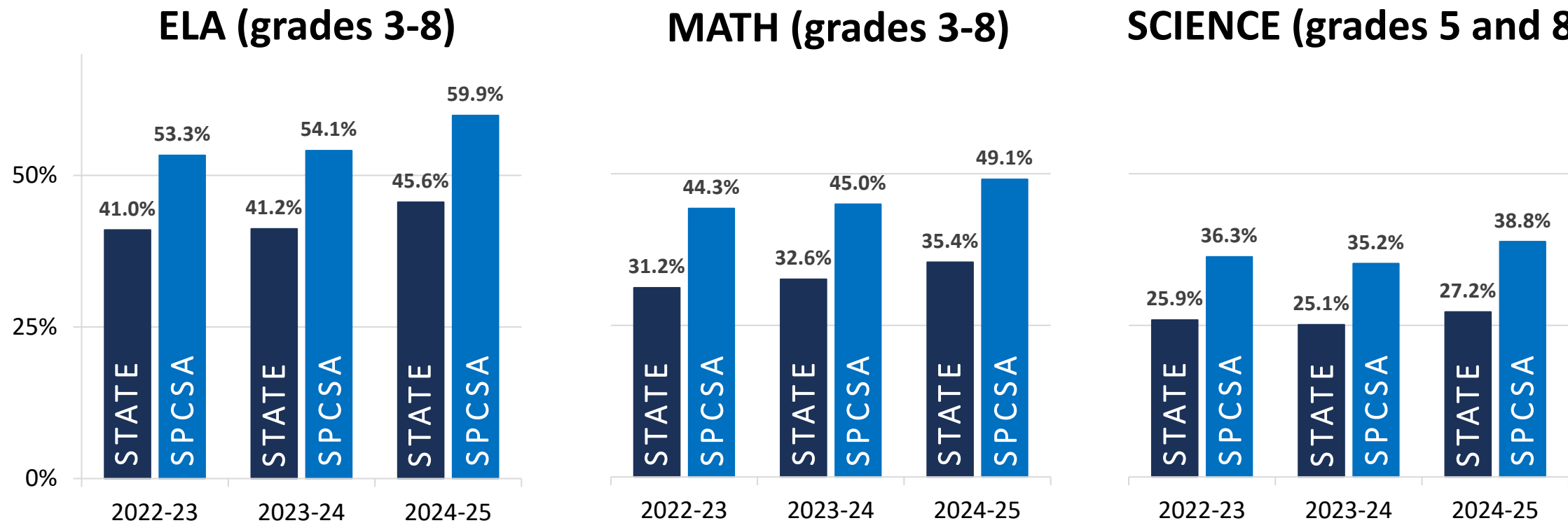
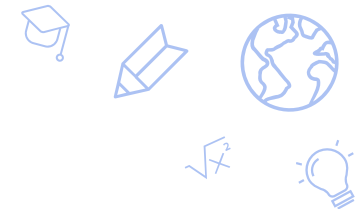

Additional Targeted Support and Improvement (ATSI)

Schools with very low performing student groups (lowest 5th percentile). Schools spend three years as an ATSI school and must meet certain criteria to exit.

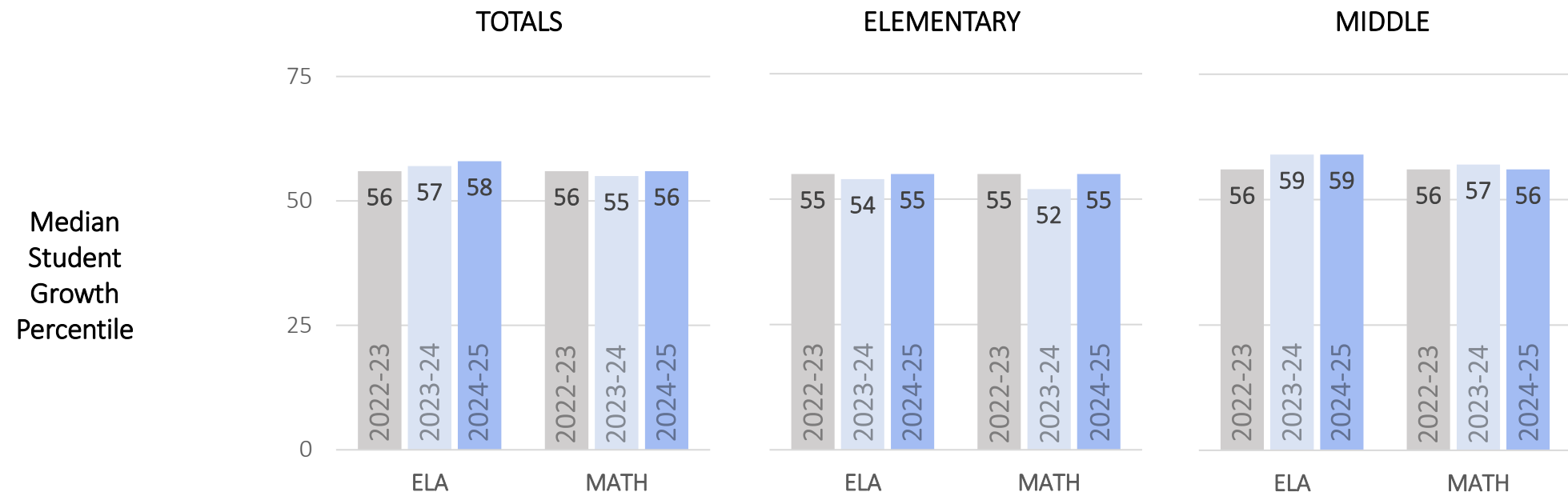
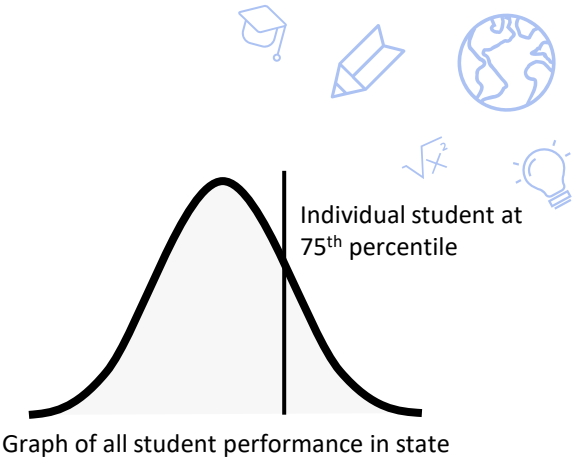
2024-25 SPCSA vs. State: Smarter Balanced Proficiency Trends



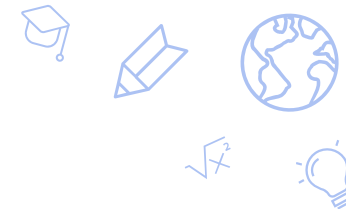
SPCSA proficiency rates (overall and for student groups) have generally increased in recent years and also outperform the state.

SPCSA NSPF Median Growth Percentiles Trend

- The NDE uses at least two years of a student’s Smarter Balanced assessment data to calculate growth.
- The NDE calculates how much growth a student has made—compared to their peers—via a Student Growth Percentile (SGP) from 1 to 99. An SGP of 75 means a student has shown more growth than 75% of their peers.
- A school Median Growth Percentile (MGP) is the median of all student SGPs.

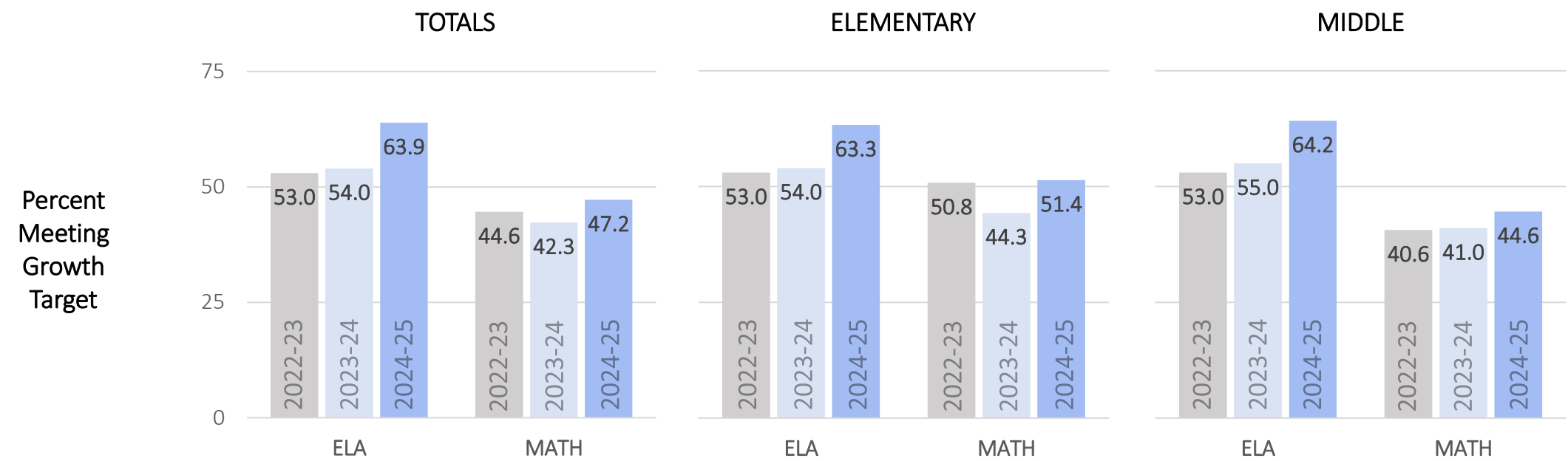


Generally, median growth trends are mixed over time.



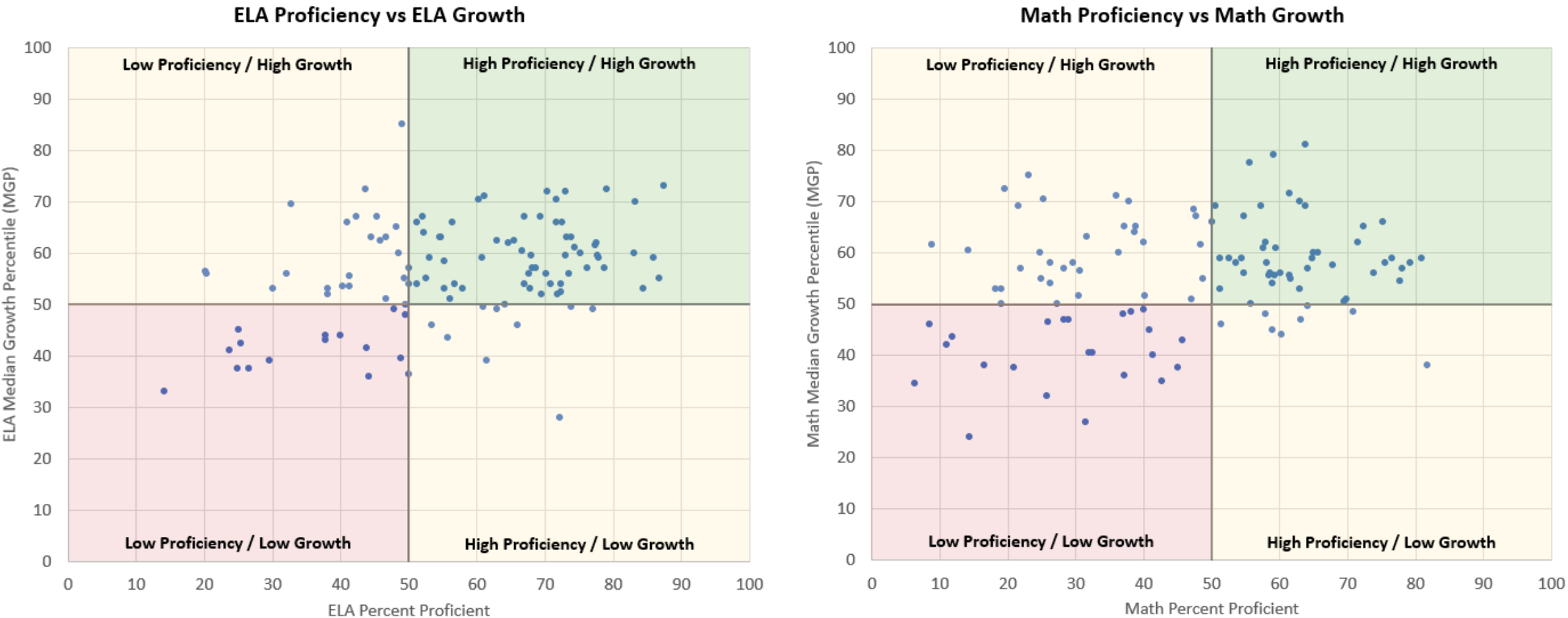
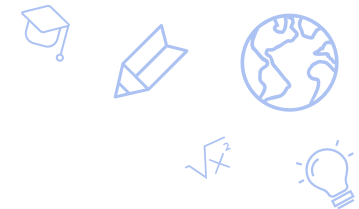
SPCSA NSPF Meeting Growth Targets Trend

- The NDE uses Adequate Growth Percentiles (AGP) to determine if a student has made enough growth to be on track to remain or become proficient.
- A school AGP rate is the percent of students meeting their growth target. If a student meets their target, they are on track to remain or become proficient.
- Adequate Growth Percentiles is worth up to 15 points in the elementary school NSPF and up to 10 points in the middle school NSPF.



The percent of students meeting their growth targets increased over last year.

SPCSA School Proficiency Versus Growth



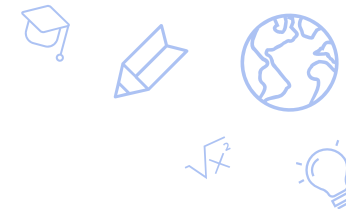
For ELA, many SPCSA schools have high proficiency and growth. For Math, the results are more mixed.

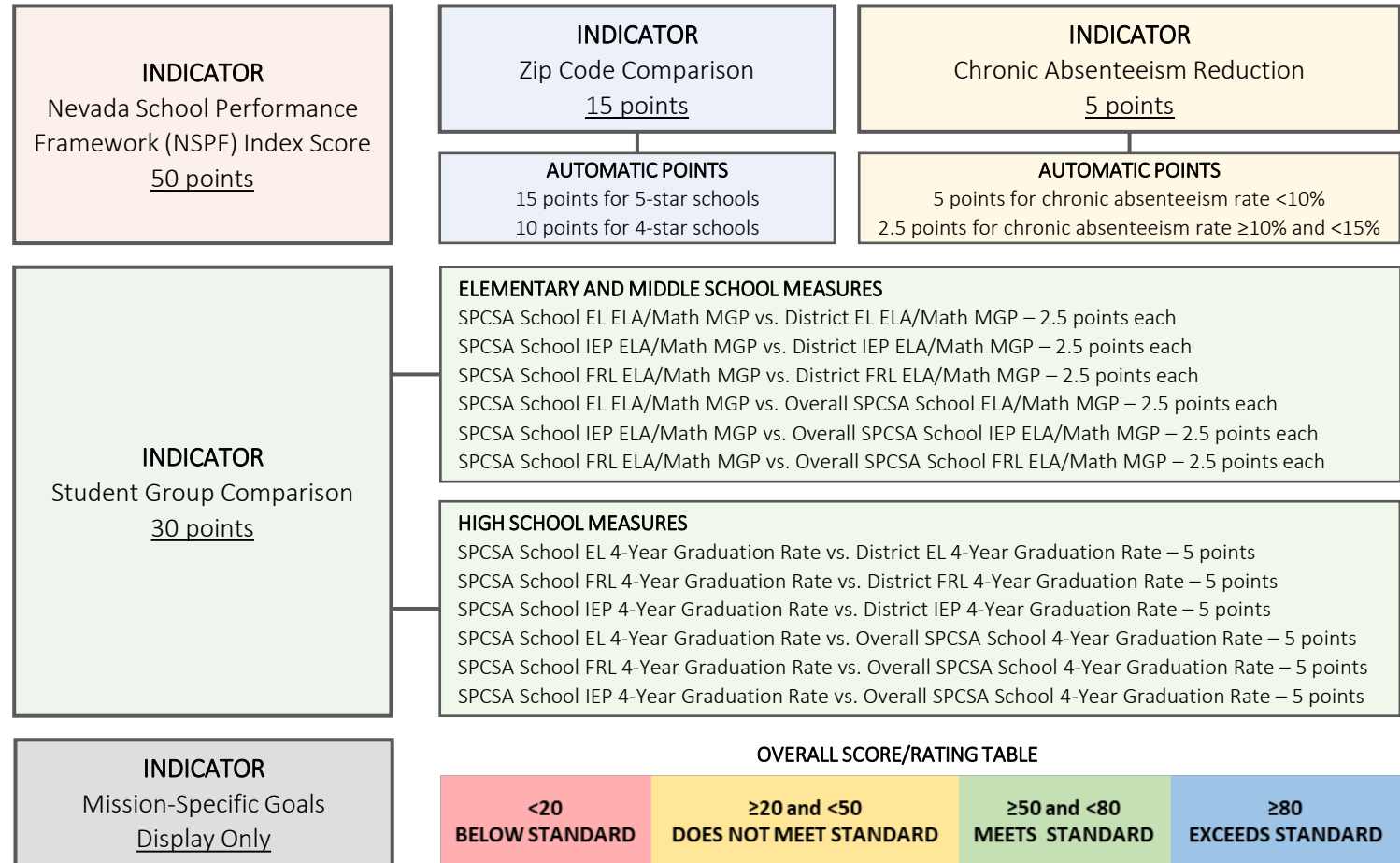

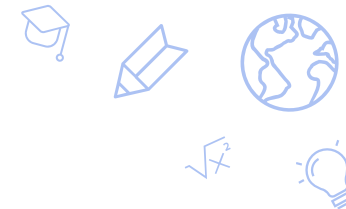


SPCSA Academic Performance Framework Refresher

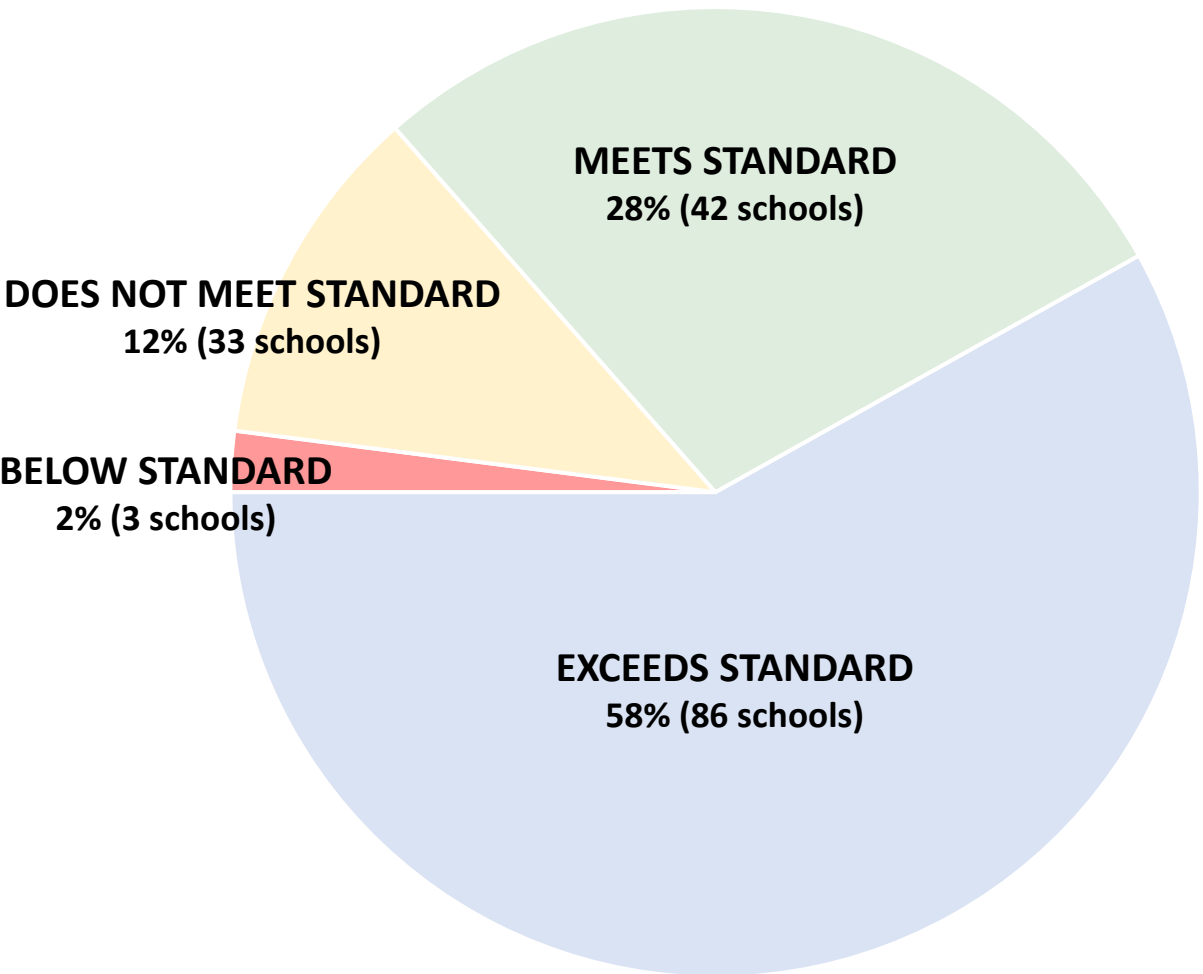


- Schools earn points based on their performance in the measures.
- Points for measures are totaled under indicators, and indicators are summed to a score from 1 to 100.
- The point total is then tied to one of four performance levels (ratings):
 - Exceeds Standard
 - Meets Standard
 - Does Not Meet Standard
 - Below Standard
- Generally, to receive a rating, an NSPF star rating is required.
- Framework results annually published around November for prior school year.





2024-25 SPCSA Academic Performance Framework Ratings



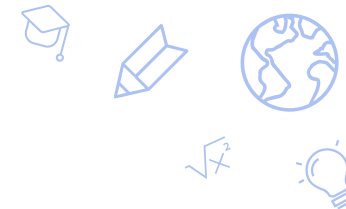

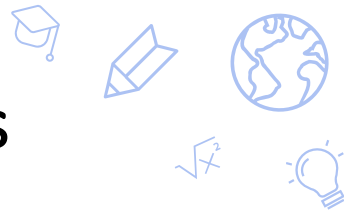
INDICATOR Zip Code Comparison	How are SPCSA schools performing versus other public schools in their community? 117 of 148 = 79% of SPCSA schools had an NSPF score at or above the average NSPF score for schools in their zip code.
INDICATOR Chronic Absenteeism Reduction	Are SPCSA schools reducing chronic absenteeism? 102 of 148 = 69% of SPCSA schools had a reduction in their chronic absenteeism rate.
INDICATOR Student Group Comparison	How well are SPCSA schools serving at-risk student groups? Examples: 81 of 110 = 74% of SPCSA elementary/middle schools had a FRL Math MGP above district FRL Math MGP. 25 of 26 = 96% of SPCSA high schools had a FRL graduation rate above district FRL graduation rate.



Takeaways: 2024-25 SPCSA Academic Performance

- NSPF, Proficiency, and Growth
 - About 85% of SPCSA schools achieved a three-star or higher NSPF rating, which outperformed the state (~54% of schools were 3-star or higher) and all Nevada districts except two small districts.
 - Generally, proficiency rates in ELA, Math, and Science have increased in recent years for the SPCSA and its student groups, and rates outperform the state. However, many students are still not meeting grade-level proficiency expectations.
 - SPCSA median growth is mixed in recent years, but the percent of SPCSA students meeting their growth targets have increased.
- SPCSA Academic Performance Framework
 - About 86% of SPCSA schools received a Meets or Exceeds Standard rating.
 - About 80% of SPCSA schools had an NSPF score at or above the average NSPF score for schools in their zip code.

Authority Oversight of Academic Performance



NRS 388A.150 **Creation; purpose.**

1. The State Public Charter School Authority is hereby created. The purpose of the State Public Charter School Authority is to:

(a) Authorize charter schools of high-quality throughout this State with the goal of expanding the opportunities for pupils in this State, including, without limitation, pupils who are at risk.

(b) Provide oversight to the charter schools that it sponsors to ensure that those charter schools maintain high educational and operational standards, preserve autonomy and safeguard the interests of pupils and the community.

(c) Serve as a model of the best practices in sponsoring charter schools and foster a climate in this State in which all high-quality charter schools, regardless of sponsor, can flourish.

Authority Oversight of Academic Performance: State Law/Regulations



- Poor academic performance for an SPCSA school may result in Authority action, per Nevada state law and regulation:
 - Mandatory termination¹
 - Three one-star NSPF ratings in three consecutive school years, with a narrow and temporary exception.
 - Permissive termination²
 - High schools – a graduation rate under 60 percent for the immediately preceding school year.
 - Elementary and middle schools – lowest 5 percent in NSPF score statewide for the immediately preceding school year.
 - Elementary, middle, and high schools – receives a one- or two-star NSPF rating in each of the last three ratings OR has “not complied consistently” with the SPCSA Performance Framework.
- Historically, the Authority has issued academic notices to notify one- and two-star schools and their governing boards of academic underperformance. With continued underperformance, the Authority may escalate a notice, or in extreme cases, terminate a charter contract as authorized under state law/regulation.
 - Historically, the Authority has issued Notices of Concern, Notices of Breach, and Notices of Intent to Revoke, in order of severity.

¹[NRS 388A.300](#) and [SB460](#) (2025). Per [NRS 388A.274](#), charter schools approved to be rated on the Nevada Alternative Performance Framework are exempt from mandatory termination provisions. [SB460](#), as passed by the 2025 Nevada Legislature, provides a temporary and narrow exception to mandatory closure when schools are within range of a 2-star NSPF rating.

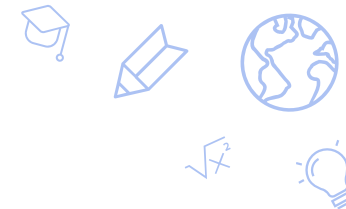

Academic Performance Recommendations Overview

- **Remove Notices for Academic Performance.**
 - SPCSA staff recommend prior Academic Notices be removed from specified schools that received, for the 2024-25 SY, a three-star or higher NSPF rating or a Meets or Exceeds Standard rating on the SPCSA Academic Framework.
- **Issue Notices for Academic Performance.**
 - SPCSA staff recommend Academic Notices of Concern be issued to specified schools that received, for the 2024-25 SY, a one- or two-star NSPF rating and a Below or Does Not Meet Standard rating on the SPCSA Academic Framework.
 - SPCSA staff recommend Academic Notices of Breach be issued to specified schools that received, for the 2024-25 SY, a second consecutive one-star NSPF rating.
- **Revise Notices for Academic Performance.**
 - SPCSA staff recommend Academic Notices of Concern be elevated to Academic Notices of Breach for specified schools that displayed continued academic underperformance by receiving a one-star NSPF rating in the 2024-25 school year.
 - SPCSA staff recommend Academic Notices of Breach be reduced to Academic Notices of Concern for specified schools that improved or maintained academic performance by receiving a two-star NSPF rating in the 2024-25 school year.
- **Continue Notices for Academic Performance.**
 - SPCSA staff recommend Academic Notices be continued for specified schools with academic underperformance.

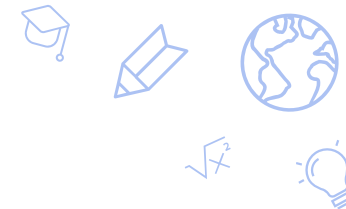

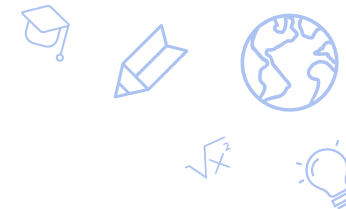

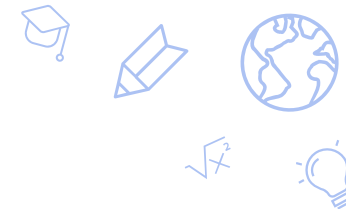

Schools with prior Academic Notices of Breach: Generally, except in unique or extreme circumstances, SPCSA staff will not recommend the Authority escalate Academic Notices of Breach to Academic Notices of Intent to Revoke unless a school has received three consecutive one-star NSPF ratings and did not meet [SB460](#) exemption criteria, in alignment with mandatory termination provisions outlined in statute.¹ However, the Authority may choose to escalate notices based on permissive termination provisions² (schools with a 1 or 2-star NSPF rating “during the last three ratings” or “not complied consistently” with SPCSA Academic Performance Framework).

Schools with prior Academic Notices of Concern: Generally, except in unique or extreme circumstances, SPCSA staff will not recommend the Authority escalate Academic Notices of Concern to Academic Notices of Breach for schools that achieve a two-star NSPF rating.
