DECLARATION OF M HIETT

- I, Manual Hiett, hereby declare under penalty of perjury as follows:
- 1. I am a current student at Nevada Connections Academy's high school. I make this declaration in support of NCA relative to closure proceedings before the State Public Charter School Authority held on May 25, 26, and 27, 2017, and continued to an unspecified date in 2017.
- The matters set forth in this declaration are based on my own personal knowledge.
 If called upon to testify, I am competent to testify to the matters set forth herein.
- 3. It breaks my heart to hear that Nevada Connections Academy may be closing. This school truly changed my life, it gave me opportunities to do things I never thought I could do. The teachers are amazing and even though it's an online school, it's also a public school. This school made me feel more included than I felt at any public school where you physically sit in a classroom with other teachers and students. Constantly, you are involved in discussions with your peers, and your teachers make a huge effort to keep in contact with you and make sure you're giving it your all.
